Hi Derek

I do not have access to the locations where the documents for the application are held. I'm aware that there are changes to the ES and would appreciate sight of them. Could I ask that a copy of the CD be posted to me please.

In the meantime I would state that the Clyde Fishermen's Association objects to the proposal unless the same conditions lending a degree of protection to the fishing industry are included in the new consents.

The condition I refer to is in "Consent Conditions Part1 paragraph 16" of the previous consent. It states:

16. Prior to the Commencement of Development, the Company shall submit to Scottish Ministers a Fishing Mitigation Plan developed in conjunction with Clyde Fishermen's Association, the objective of which is to minimise the impacts the Development may have on fishing interests and agree appropriate mitigation. No part of the Development shall be commenced until the Scottish Ministers have approved the Fishing Mitigation Plan in writing. All works forming part of the Development shall be carried out in strict compliance with the Fishing Mitigation Plan.

Reason: To protect fishing interests.
