KOWL - Fisheries Management and Mitigation Strategy (FMMS) – Consultation

The Scottish Fishermen's Federation (SFF) is pleased to respond to this consultation on behalf of the 500 plus fishing vessels in membership of its constituent associations:- the Anglo Scottish Fishermen's Association, the Fife Fishermen's Association, the Fishing Vessel Agents and Owners Association (Scotland) Ltd, the Mallaig and North-West Fishermen's Association, the Orkney Fisheries Association, the Scottish Pelagic Fishermen's Association Ltd, the Scottish White Fish Producers Association Ltd and the Shetland Fishermen's Association.

As the majority of our members are family businesses the potential loss of millions of pounds of income is a significant imposition, so the SFF would prefer the sentence on page 8, beginning "Impacts on trawling fisheries activities....." was given clarity and context as it appears to downplay the importance of fishing in the local environment.

Upon agreement of this FMMS, the SFF would expect prompt discussions with the FLO regarding the rock placement paper discussed in 4.5 Export cable route on page 13.

On page 17, clarity is required as the two boxes concerning "Active seagoing fishermen" are meant to represent Static and Trawling, but include exactly the same wording?

The opening sentence in *Licensing* on page 26 is incorrect. Static gear fishermen, fishing in order to sell & profit must be licensed whether part or full time. There is a restriction on what a hobby fisherman may keep, and he cannot sell for profit.

If these points are addressed, the SFF is content with the paper,
