(g) Method statement including schedule of work (continue on separate sheet if necessary):

The net design is shown in the attached diagram. The net will be positioned with the leader and fyke net lying perpendicular to shore, and wings approx 30 degrees from leader. The leader will be attached at the shore, the wings and four corners of the heart of the net and the back of the fyke will be anchored using 50kg grapnel anchors. Float line along the leader, wings and heart will keep the net on the surface and visible. Buoys will be used on all anchors and the end of the fyke to alert passing traffic. The heart and fyke net will be underwater at all times, the shore end of the leader and wings may cover the entire water column at some tides. At Kilchoan harbour site we will also deploy a sentinel cage 1.5m diameter by 2m deep, adjacent to the net (see sentinel cage method statement document).

The net will be deployed in mid April and fished for three months. The net will be checked daily from a Polar Circle rib. Fish will be removed through trapdoors in the net using hand nets. All salmonids will be anesthetized, weighed, measured and checked for lice. All non target fish and recovered salmonids will be returned to the water. In periods when the net cant be checked the back of the fyke will be left open to allow fish to escape. The net and anchors will be removed between mid July and mid August.

The purpose of this work is to record sea lice levels on wild salmonids in order to inform the management of neighbouring fish farms. The project is being carried out in collaboration with Fishery Management Scotland, Crown Eststae, Marine Scotland Science and Marine Harvest

Non-target species will be caught in the net. The residence chamber is large and will accommodate a large number of fish before stress by overcrowding becomes an issue. The net will be checked at least once daily and non-target species released immediately.

Otters could enter the fyke section of the net and drown. We will use otter guards, as Marine Scotland do in their fyke nets.
