Notice is hereby given that each of **Moray Offshore Renewables Limited**, Registration Number 07101438, **Telford Offshore Windfarm Limited**, Registration Number 07386810, **Stevenson Offshore Windfarm Limited**, Registration Number 07386838 and **MacColl Offshore Windfarm Limited**, Registration Number 07386891, all at 1st Floor, 14/18 City Road, Cardiff, South Glamorgan, CF24 3DL, have applied to the Scottish Ministers for:

1. Consents, pursuant to Section 36 of the Electricity Act 1989, to construct and operate: Telford Offshore Windfarm, Outer Moray Firth, central grid reference 518196 E, 6456097 N (WGS84 UTM30N), Stevenson Offshore Windfarm, Outer Moray Firth, central grid reference 512920 E, 6450656 N (WGS84 UTM30N) and MacColl Offshore Windfarm, Outer Moray Firth, central grid reference 517278 E, 6444336 N (WGS84 UTM30N). The installed capacity of each proposed generating station would be up to 500 MW, comprising up to 139 turbines in each wind farm site with a tip height of up to 204 metres from LAT; and
2. Marine Licences, pursuant to Section 65 and 66 of the Marine and Coastal Access Act 2009, for the deposit of substances and objects and the construction, alteration or improvement of works within the Scottish Offshore Region in relation to Telford, Stevenson and MacColl wind farms.
3. A Marine Licence, pursuant to Section 20 of the Marine (Scotland) Act 2010 and Section 65 and 66 of the Marine and Coastal Access Act 2009, for the deposit of substances and objects and the construction, alteration or improvement of works within the Scottish Marine Area and Scottish Offshore Region in relation to offshore wind farm transmission works.

Representations should be dated and should clearly state the name (in block capitals) and full return email or postal address of those making representation. All representations to the Scottish Government will be copied in full to the planning authority.

When initial comments from statutory consultees are received further public notices will give advice on how this information may be viewed by members of the public, and how representations may be made to Scottish Ministers. During the consideration of the proposal, Scottish Ministers may formally request further information to

supplement the Environmental Statement and this will also be advertised in such a manner.

Where Scottish Ministers decide to exercise their discretion to do so, Scottish Ministers can cause a Public Inquiry to be held.

Following receipt of all views and representations, Scottish Ministers will determine the application for consent in one of three ways: Consent the proposal as it stands or Consent the proposal with conditions; or Reject the proposal
