Also I believe that the company has achieved a balance in the impact that it will have on the environment.



#### Comments on Moray Offshore Renewables Ltd Environmental Statement

These comments concentrate on the quantitative employment and GVA sections of Chapter 8.6 and with passing reference to Chapter 15.6 and the Planning Statement. The comments are offered without reference to the original Terms of Reference of the study.

#### Main Environmental Statement

- 8.6.5.1 The 'local' study area is wider than HIE would ideally choose and includes Highland, Moray, Aberdeenshire and Aberdeen City. However, it does not include Fife and therefore BiFab, which, depending on assumptions regarding fabrication, could have a significant bearing on 'local' impacts.
- 8.6.5.15 Since the impacts are so sensitive to assumptions surrounding local content, it would give more comfort if some flavour of the geographic allocation processes gone through were discussed here, subject to commercial confidences of course. This might include naming key Scottish suppliers, their capabilities and general issues. For example, what assumptions were made regarding the fabrication and installation of sub-structures (a major capital expenditure component which could have large local content).
- 8.6.5.16 Why include this at all? It is not a worst case scenario.
- 8.6.6.3 The methodology is a top-down approach starting with a large capital expenditure of £4.5billion, which is itself based on a single round figure of £3m per MW of installed capacity. How much confidence is there in this figure it is clearly fundamental to the backwards calculation from this point?

In making assumptions regarding geographic fulfilment of orders (again with specific reference to sub-structures), has production capacity been taken into account, including the availability of skilled labour? The scale of the capital investment is unprecedented and this would influence assumptions regarding choice of suppliers in the north of Scotland or further afield.

- 8.6.6.4 This all seems logical, however, more detail and examples would be welcome.
- 8.6.6.6 With regard to local content, there could be a very large gap between low and high case scenarios at this stage (the high could be a multiple of the low) since we don't know where key contracts are likely to be placed. However, maybe with more industry input into the study the base case could have been improved by using a probability (percentage likelihood) approach to estimating local content. Perhaps this was done, but can't be seen without reference to more methodological detail.
- 8.6.6.11 It is hard to comment on retention within Scotland without detailed knowledge of the assumptions. The 4 project phases outlined in Table 8-6-6 mask what would be a detailed breakdown of the construction and commissioning phase which would include huge opportunities for Scottish fabrication yards. Perhaps taking 2011 as the base case is too pessimistic given the progress that might be made in their readiness

in the run up to the construction and commissioning phase. This is reflected in paragraph 8.6.6.13 and at 8.6.6.8

- 8.6.6.16 Perhaps with more industry input, the employment estimates could be triangulated with industry norms for the labour content of key contracts (typically the management accounts of a supplier might show percentages categorised by materials, equipment, labour, overheads and profit). Knowledge of industry wage rates banded by labour type (e.g. skilled, semi-skilled, technical/engineering, management and administration) would allow the employment impact to be estimated from a different direction, less reliant on national multipliers (which is a crude approach, but admittedly necessary in the absence of better data).
- The Scotland optimistic scenario of 21,800 job-years seems in the right ball-park.

  This is 14.5 job-years per MW, excluding transmission infrastructure. Snedden Economics work in 2005 examining the Beatrice full farm of 200 turbines totalling 1GW estimated 16 UK job-years per MW of installed power.
- 8.6.6.18 The job-year approach is the best way to show the impact over time and these profiles seem reasonable. The local content mix would change over time and perhaps could be displayed in a similar manner.
- Relating to the earlier point (8.6.6.3) regarding labour availability and capacity, the employment impact is described as 'major positive'. If large orders were being fulfilled e.g. at Scottish fabrication yards in a relatively short space of time there could be implications for other projects such as Beatrice. Labour will be an important factor of production and competition for labour could become an issue, in which case some discussion of displacement would be appropriate. Capacity constraints are mentioned in the Cumulative Impacts section (Table 15.6.1) in relation to BOWL. Arguably, the issue arises from the scale of the MORL investment alone.
- 8.6.6.26 GVA is estimated from I-O tables based on initial capital expenditure and similarly for operational expenditure. Many of the same points made above therefore apply to the GVA estimates, not least the importance of the initial capex estimates and the assumptions regarding local content particularly for fabrication and installation contracts. Also, the appropriateness of sectors in I-O tables will at best be crude, which is recognised by the authors.

#### P43 Planning Statement

6.4.6 "the maximum GVA of £1,848m equates to approximately 1.5% of Scotland's Gross Domestic Product for 2011". This is potentially a misleading statement – the £1,848m is a contrived total of maximum impacts at each of the construction, operational and decommissioning stages. They cannot all happen simultaneously. GDP is an annual measure and the two are therefore not comparable.

Following on from HIE's original submission, I have realised that the appropriate covering note was not included.

Highlands and Islands Enterprise would wish it to be noted that we are fully supportive of the proposed development and the positive economic impacts that it can bring to the Highlands and Islands in particular and Scotland as a whole.

Along with Scottish Enterprise, EDPR and Repsol have worked with HIE on a supply chain pilot, which is aiming to maximise the potential local content through the development of the local supply chain. This scheme is to enable the enterprise agencies to access appropriate parts of the project's procurement process.

The pilot has been taking the form of frequent engagement between Moray Offshore Renewables, HIE and Scottish Enterprise. The intention has been to allow partnership working between the public and private sector to facilitate the optimisation of support to the supply chain. The information provided by Moray Offshore Renewables is intended to allow the agencies which translate new markets into growth and prosperity to optimise their efficiency, effectiveness and success, with due respect to commercial confidentiality and commercial sensitivity.
