Explanatory Notes

- (e) Provide the cost of the works seawards of the tidal limit of MHWS. This estimate should only cover work taking place below the tidal level of MHWS and must take into consideration the cost of materials, labour fees etc.
- (f) Describe the location of the proposed works. Include a list of the latitude and longitude co-ordinates (WGS84) of the boundary points of the moorings area and for each of the component parts of the marine farm, including sub-surface equipment. WGS84 is the World Geodetic System 1984 and the reference co-ordinate system used for marine licence applications. Co-ordinates taken from GPS equipment should be set to WGS84. Coordinates taken from recent admiralty charts will be on a WGS84 compatible datum. Ordnance survey maps do not use WGS84.

Example: For positions read from charts the format should be as in the example: 55°55.555'N 002°22.222'W (WGS84). The decimal point specifies that decimals of minutes are used and the datum is stated explicitly. If seconds are used then the format should be as in the example: 55°55'44"N 2°22'11"W (WGS84).

It is important that the correct positions, in the correct format, are included with this application, as any errors will result in the application being refused or delayed.

To supplement your application, please provide a suitably scaled extract of an Ordnance Survey Map (1:2,500 scale but not more than 1:10,000) or Admiralty Chart which must be marked to indicate:

- the full extent of the works in relation to the surrounding area;
- latitude and longitude co-ordinates defining the location of the works;
- the level of MHWS;

Drawings and plans will be consulted upon. If they are subject to copyright, **it is the responsibility of the applicant to obtain necessary approvals to reproduce the documents and to submit suitably annotated copies with the application.**

- (g) Indicate if the marine farm is located within the jurisdiction of a statutory harbour authority and provide details of the statutory harbour authority where relevant.
- (h) Provide assessment of the potential impacts the works may have on navigation, including interference with other uses of the sea.

Where there are potential impacts from the works, please provide details of proposed mitigation in response to potential impacts.

6. Planning Permission

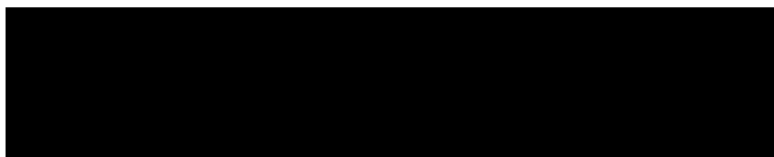

The purpose of the application is to maintain consents for an existing marine farm asset. The application is in alignment with policy GEN 1, supporting the ongoing operation of marine farms in Badcall Bay which are operating with good practice & performance compatible with the NMP's Aquaculture policies (in particular AQ 1, 3, 12 & 14). Supporting the ongoing farm operations also aligns with policies GEN 2 & 3, ensuring continued socio-economic benefit in the local area in terms of employment, training opportunities, local community engagement and supply-chain use. There are no historic environment (GEN 6) or natural heritage interests (GEN 9) affected, and being an existing site within an area of well-established aquaculture activity no negative impact on landscape, seascape or local amenity are identified (GEN 7 & AQ 5). Finally, in alignment with policy AQ 11, all equipment deployed by LD is fit for purpose and will be routinely maintained by the operator to ensure it stays as such.

Neighbouring marine farm 05675 which is the currently active farm within Badcall Bay; also marine farms 05676 & 05678 in the bay. In application is a freshwater pipeline routed to the active site to facilitate non-medicinal fish health management, and proposal for a freshwater storage facility associated with the pipeline is in development. Note that not all equipment will be deployed together, and this application alongside applications to renew 05676 & 05678 are to maintain consents for these marine farm assets.
