1.0 Introduction

- 1.1 Fairhurst have been appointed by The Highland Council to prepare a Pre-application Consultation (PAC) Report in support of a construction marine licence application for the A836 Naver Bridge Replacement Scheme ("the Proposed Scheme"). Overall, the Proposed Scheme comprises:
 - Approximately 450m of new carriageway including verge widening & tie-ins to A836;
 - 65m bridge (comprising a prestressed and reinforced concrete composite beam and slab structure with three spans); and
 - New Lay-by, Bus turning area & private accesses.
- 1.2 This report outlines the pre-application consultation process, which has been undertaken to enable the applicant to effectively engage with local communities and stakeholders. The consultation strategy was designed to reflect guidance within the Pre-Application Consultation procedure, in accordance with Sections 22, 23 and 24 of the Marine (Scotland) Act 2010 and with the Marine Licensing (Pre-application Consultation) (Scotland) Regulations 2013.
- Due to the COVID-19 pandemic and the current physical distancing guidance in place, the regulations have been amended by The Marine Works and Marine Licensing (Miscellaneous Temporary Modifications) (Coronavirus) (Scotland) Regulations 2020, which came into force on 20th May 2020. Under these amending regulations, where a pre-application consultation event must be held, this is now to be held online, with the public notice reflecting this.
- 1.4 During the consultation period, a range of communication methods were used to provide information about the Proposed Scheme and to ensure that people had the opportunity to offer their opinions and feedback on the proposals. The communication methods are discussed further in this report.
- 1.5 A completed PAC Report Form (Regulation 8 Schedule) including Signed Certification is also included in Appendix 7 of this report. All relevant supporting documentation and evidence relevant to this PAC Report is included in the appendices.



2.0 The Proposed Scheme

Background to the Scheme

- 2.1 This section outlines the needs case of the proposed Scheme.
- 2.2 The A836 road begins at the South end of the Dornoch Bridge and ends at John o'Groats, passing through Lairg, Tongue and Thurso. Naver Bridge carries the Tongue to Bettyhill section of the A836 over the River Naver at Bettyhill. It forms part of the North Coast 500 tourist route. It is a mix of single carriageway and single track with passing places. The east approach to the bridge is single carriageway and the west approach is single track with passing places, and the bridge itself is single track with no verges.
- 2.3 The existing structure is a three span wrought iron through girder bridge with a total length of approximately 62m. The substructure comprises stone masonry abutments which are situated within the River Naver. The bridge superstructure is in a poor condition and is considered to be of an age and structural type that any refurbishment scheme would be extensive and costly.
- 2.4 The bridge is narrow with only room for a single traffic lane and no provision for cyclists or pedestrians. The approach alignment is poor, particularly from the East, which coupled with the through girders means that forward visibility is substandard. The poor alignment combined with the poor condition of the structure means that a full replacement and realignment of the structure and approach roads is required. As part of this replacement scheme the existing bridge would need to be demolished.

Proposed Scheme

2.5 The existing structure is a three span wrought iron through girder bridge with a total length of approximately 62m. The substructure comprises stone masonry abutments and piers which are situated within the River Naver. The bridge superstructure is in a poor condition and is considered to be of an age and structural type that any refurbishment scheme would be extensive and costly.



- 2.6 The bridge is narrow with only room for a single traffic lane and no provision for cyclists or pedestrians. The approach alignment is poor, particularly from the East, which coupled with the through girders means that forward visibility is substandard. The poor alignment combined with the poor condition of the structure means that a full replacement and realignment of the structure and approach roads is considered to be the most appropriate option. As part of this scheme the existing bridge would need to be demolished. It is anticipated that the superstructure could be lifted from the supports in three or more parts before being cut into smaller sections and removed from site.
- 2.7 The Proposed Scheme comprises over 450m of new carriageway and a 65m three span bridge. The new structure is situated to the south of the existing bridge over the River Naver, one mile south of Bettyhill.
- 2.8 The Proposed Scheme will involve realignment of the existing carriageway and provision of a new bridge crossing which aims to provide a more compliant road geometry and visibility which will lead to a safer section of road. It is considered that the new carriageway construction will likely be formed by cutting into the existing rock formation on the east side and onto new embankment and cutting on the west side. The proposed 65m structure comprises a prestressed and reinforced concrete composite beam and slab structure with three spans. Span length and support locations have been optimised with careful consideration of road alignment options and the effect of the bridge on the hydrology of the River Naver.



3.0 Approach to Consultation

Consultation - Background

- 3.1 The approach to community engagement reflects the requirements and aims of the engagement process as set out in accordance with Sections 22, 23 and 24 of the Marine (Scotland) Act 2010 and with the Marine Licensing (Pre-application Consultation) (Scotland) Regulations 2013.
- 3.2 The legislation applies to all relevant marine licence applications submitted to Marine Scotland and the Proposed Development fall within the criteria that is subject to the public pre-application consultation procedure under this legislation.
- 3.3 The Marine Scotland Guidance sets out that "Public pre-application consultation consists of at least one public event where local communities, environmental groups, NGOs, regulators and other interested parties are given the opportunity to consider and comment upon a prospective application for those marine licensable activities that are prescribed in the Regulations".
- 3.4 Careful consideration for hosting the public consultation event was required due to the ongoing COVID-19 pandemic. The regulations have been amended by The Marine Works and Marine Licensing (Miscellaneous Temporary Modifications) (Coronavirus) (Scotland) Regulations 2020, which came into force on the 20 h May 2020. Under these amending regulations, pre-application consultation events, are now allowed to be held online, with the public notice reflecting this.
- 3.5 Throughout the consultation, Fairhurst has ensured that the stakeholders have been appropriately identified, had access to relevant information, and have the opportunity to participate in the consultation. To do this, a proactive consultation strategy was undertaken to ensure the required information was circulated to a wide number of stakeholders. Throughout the public engagement process, Fairhurst have been committed to:
 - Providing easily accessible information on the Proposed Scheme;
 - Provide direct means of communication to ask questions, comment and enquire; and



 Identifying a variety of stakeholders and applying appropriate communication techniques.

Consultation Process

- 3.6 The consultation period commenced on the 13th August 2021 and ran until the 8th October 2021. This included a period of 6 weeks between the consultation period being advertised in the newspaper and stakeholder notifications to the live online consultation event (held on the 24th September 2021). Prior to the preparation of the PAC report, a further 2 weeks followed the live online consultation event, which would allow any consultation responses to be received. This was considered a suitable period of time, particularly as there had been no responses received and no participants took part in the consultation event.
- 3.7 The online consultation website went live on the 5th July 2021, which included consultation boards and details of the live online consultation event. To help inform participants of the proposed scheme, Fairhurst produced a set of consultation boards, which included information on: The Application Site; The Proposed Scheme; Environmental Considerations; and Information on Next Steps (including information on being notified of a subsequent live online consultation event)

Live Online Consultation Event

3.8 The live online consultation event was hosted on Microsoft Team's on 24th September 2021 at 13:00. Despite the consultation invitation methods, no participants took part in the event. The presentation and proof that the event took place is located within Appendix 4 of this PAC report.

Communication Methods

- 3.9 During the consultation period, a range of communication methods were used to provide information about the Proposed Development and to ensure that people had the opportunity to offer their opinions and feedback on the proposals. The consultation methods included:
 - A dedicated project website page, found at: https://www.fairhurst.co.uk/consultation/naver-bridge/.



- As per the legislative requirements, the Proposed Scheme was advertised in the John O'Groats Journal Newspaper at least seven days in advance of the consultation period. The advert was placed on the 13th August 2021. A copy of the notice can be located within Appendix 1 of this PAC report;
- An online presentation via Microsoft Teams (in replacement of a public event due to COVID 19);
- Direct email communication to the following Stakeholders:
 - The Commissioners of Northern Lighthouses;
 - The Maritime and Coastguard Agency;
 - o The Scottish Environment Protection Agency; and
 - Nature Scott (Previously Scottish Natural Heritage)
- 3.10 The prospective applicant must notify the above mentioned statutory consultees that an application is to be submitted to Marine Scotland via direct email. All contactable statutory consultees responded to the notification email and copies can be found within Appendix 6. It should be noted that Marine Scotland confirmed that there is no delegate for the North Coast Marine Region currently, confirmation is also found in Appendix 6.



4.0 Consultation Findings

- 4.1 The consultation period took place between 13th August 2021 and 8th October 2021. During the consultation period, no representations were received from the public or any non-statutory consultees. There were also no participants for the online consultation event on the 24th September. Despite no confirmed attendees, Fairhurst held the online consultation event, to confirm that there were no drop-ins and to ensure continuity throughout the consultation period. A demonstration of the live online consultation event is provided in Appendix 4.
- 4.2 All statutory stakeholders that were contacted during the consultation period did respond, a summary of the responses is provided below:

Consultee	Response
Northern Lighthouse Board	13/08/21 - No objections to this proposal and will reply to the full Marine Licence application.
Maritime & Coastguard Agency	17/08/21 -Will reply to the full Marine Licence application. Did not that there is interest due to the navigation of small vessels, therefore will most likely require a methodology, and the potential impact on marine users in the full application.
SEPA	18/08/21 – SEPA confirm advice was already provided outside of the PAC process. Fairhurst can confirm that the advice was considered during the early design of the Proposed Development. There was no specific advice to make on the marine element of the application and simply refer to the standing advice.
NatureScot	30/09/21 – Nature Scot confirmed that comments given at the EIA screening stage (21/02260/SCRE) remain valid. These comments concluded that "the planning application should demonstrate how water quality will be protected, fish passage will be maintained and include details of any site specific mitigation measures proposed. With appropriate mitigation and site design considerations, we consider (in our preliminary view) that it should be possible to avoid adverse effects on the SAC". The response also provided standing advice for the relevant protected species and a guidance note on dealing with construction and birds.
North Coast Marine	13/08/21 - MS confirmed that there is no delegate for the North Coast Marine Region and therefore, this consultee can be removed.



4.3 Fairhurst received no objections or comments to the Proposed Scheme during the consultation period. Therefore, as a result of the PAC process, no changes were made to the Proposed Scheme. As mentioned above, a number of consultees preferred to respond to the Marine License application.



5.0 Conclusion

- 5.1 Fairhurst have been appointed by The Highland Council to prepare a PAC Report in support of a construction marine licence application for the A836 Naver Bridge Replacement Scheme ("the Proposed Scheme").
- 5.2 This report outlined the pre-application consultation process, which has been undertaken to enable the applicant to attempt to effectively engage with local communities and stakeholders, by using a range of communication methods to provide information about the Proposed Scheme, to ensure that all concerned parties had the opportunity to offer their opinions and feedback on the proposals.
- 5.3 Fairhurst considers that the pre-application consultation outlined in this PAC report, therefore, meets the guidance set out within the Pre-Application Consultation procedure, in accordance with Sections 22, 23 and 24 of the Marine (Scotland) Act 2010 and with the Marine Licensing (Pre-application Consultation) (Scotland) Regulations 2013.


The Site

The proposed development site is located to the South East of the small hamlet Invernaver and to the south of the small village of Bettyhill. The application site spans the River Naver, via the existing A836 Naver Bridge and includes land on both sides of the river.


The land surrounding the site is made up from agricultural and grazing land. There is no national landscape designations surrounding the site.

A few residential properties surround the road which forms the A836 carriageway.

The existing Naver Bridge was built over 140 years ago, without this important transport link the nearest alternative is a 26 mile diversion around Strathnaver.







The Proposed Scheme

The proposed development forms a new three span bridge adjacent to the existing bridge over the River Naver. This proposal seeks to replace the existing single carriageway bridge, which currently has no provision for pedestrians, cyclists or two way traffic.

These proposed works will include:

- · Demolition of existing bridge over the River Naver; and
- Construction of new beam and slab structure three span bridge.



The Indicative Plan above provides the current design of the proposed development - subject to change

Providing High-Quality Transport Infrastructure

The new bridge will provide a number of benefits over the existing bridge, including:

- Greater visibility and therefore safety due to the new alignment;
- Greater width to allow for two lane traffic, improving traffic flows;
- Reduced Maintenance costs compared to existing steel structure;
- Safer accesses for existing properties along the A836; and
- Improved Connectivity for Non-Motorised Users (NMUs)



Environmental Considerations

Ecology

- The span of the application site (to the south of the existing bridge) overlaps with the boundary of the River Naver Special Area of Conservation (SAC);
- A series of specialist ecology baseline surveys are being undertaken to inform the design and associated assessment process for the Proposed Scheme;
- A range of construction standard mitigation measures will be proposed that will aim to avoid or minimise potential impacts on the River Naver SAC, notable habitats and species, including Atlantic salmon and freshwater pearl mussels;
- Following completion of the specialist ecology baseline surveys, the Ecological Impact Assessment (EcIA) would assess the impacts of the Proposed Scheme on the ecological receptors and identify project specific mitigation to further minimise or compensate for potential impacts; and
- This assessment will demonstrate how water quality will be protected, fish passage will be maintained and include details of any site specific mitigation measures proposed in order to avoid adverse effects on the SAC.

Landscape

- The proposed new replacement infrastructure has the potential to affect landscape and visual receptors within the study area; and
- There are very few receptors in the locality and the Proposed Scheme design will incorporate appropriate embedded mitigation to avoid or reduce environmental impacts on the identified environmental receptors.


Noise & Air Quality

• For the construction phase, all work will be undertaken in accordance with a Construction Environmental Management Plan (CEMP) and Dust Management Plan (DMP).

Flood Risk, Drainage & Hydrology

- A Flood Risk Assessment (FRA) is proposed to accompany the planning application. The FRA
 will consider various potential sources of flood risk including joint probability fluvial/tidal
 effects established through numerical modelling of the River Naver reach upstream and
 downstream of the bridge location; and
- It is expected that any surface water discharge from the Proposed Scheme will be made to a
 tidal reach of the River Naver. On this basis, it is not anticipated that there will be any
 significant increases in flood risk from surface water run-off as a result of the Proposed
 Scheme.

Submission Autumn 2021



We are currently at Pre-Application Consultation stage, where consideration of all comments from the general public and interested parties (your views!) will be given consideration before preparation of the Pre-Application Consultation (PAC) Report, which will be submitted with the Marine License application.





Welcome

Welcome to this public consultation on the proposed marine license for a replacement for Naver Bridge, Naver, Bettyhill, Thurso.

Fairhurst are undertaking Pre-Application Consultation in support of a forthcoming Marine License application, for the proposed development of a three-span bridge, adjacent to the existing bridge over the River Naver, as part of the A836 Naver Bridge Replacement Scheme.

We value the input the public can provide during the consideration of proposed marine based development and welcome your feedback at this stage. This event has been organised in accordance with the Scottish Government's published 'Marine Licensing (Pre-application Consultation) (Scotland) Regulations 2013'.

The Site

The proposed development site is located to the South East of the small hamlet Invernaver and to the south of the small village of Bettyhill. The application site spans the River Naver, via the existing A836 Naver Bridge and includes land on both sides of the river.


The land surrounding the site is made up from agricultural and grazing land. There is no national landscape designations surrounding the site.

A few residential properties surround the road which forms the A836 carriageway.

The existing Naver Bridge was built over 140 years ago, without this important transport link the nearest alternative is a 26 mile diversion around Strathnaver.







The Proposed Scheme

The proposed development forms a new three span bridge adjacent to the existing bridge over the River Naver. This proposal seeks to replace the existing single carriageway bridge, which currently has no provision for pedestrians, cyclists or two way traffic.

These proposed works will include:

- . Demolition of existing bridge over the River Naver; and
- Construction of new beam and slab structure three span bridge.



The Indicative Plan above provides the current design of the proposed development - subject to change

Providing High-Quality Transport Infrastructure

The new bridge will provide a number of benefits over the existing bridge, including:

- Greater visibility and therefore safety due to the new alignment;
- Greater width to allow for two lane traffic, improving traffic flows;
- Reduced Maintenance costs compared to existing steel structure;
- Safer accesses for existing properties along the A836; and
- Improved Connectivity for Non-Motorised Users (NMUs)



Environmental Considerations

Ecology

- The span of the application site (to the south of the existing bridge) overlaps with the boundary
 of the River Naver Special Area of Conservation (SAC);
- A series of specialist ecology baseline surveys are being undertaken to inform the design and associated assessment process for the Proposed Scheme;
- A range of construction standard mitigation measures will be proposed that will aim to avoid
 or minimise potential impacts on the River Naver SAC, notable habitats and species, including
 Atlantic salmon and freshwater pearl mussels;
- Following completion of the specialist ecology baseline surveys, the Ecological Impact Assessment (EcIA) is being undertaken to assess the impacts of the Proposed Scheme on the ecological receptors and identify project specific mitigation to further minimise or compensate for potential impacts; and
- This assessment will demonstrate how water quality will be protected, fish passage will be maintained and include details of any site specific mitigation measures proposed in order to avoid adverse effects on the SAC.

Landscape

- The proposed new replacement infrastructure has the potential to affect landscape and visual receptors within the study area; and
- There are very few receptors in the locality and the Proposed Scheme design will incorporate
 appropriate embedded mitigation to avoid or reduce environmental impacts on the identified
 environmental receptors.


Noise & Air Quality

 For the construction phase, all work will be undertaken in accordance with a Construction Environmental Management Plan (CEMP) and Dust Management Plan (DMP).

Flood Risk, Drainage & Hydrology

- A Flood Risk Assessment (FRA) is proposed to accompany the planning application. The FRA
 will consider various potential sources of flood risk including joint probability fluvial/tidal
 effects established through numerical modelling of the River Naver reach upstream and
 downstream of the bridge location; and
- It is expected that any surface water discharge from the Proposed Scheme will be made to a tidal reach of the River Naver. On this basis, it is not anticipated that there will be any significant increases in flood risk from surface water run-off as a result of the Proposed Scheme.

Moving Forward



We are currently at Pre-Application Consultation stage, where consideration of all comments from the general public and interested parties (your views!) will be given consideration before preparation of the Pre-Application Consultation (PAC) Report, which will be submitted with the Marine License application.

Fairhurst are currently aiming to formally submit the Marine License in Autumn 2021. Marine Scotland will then respond with a formal decision approximately 13 weeks from the submission date of the Marine License Application.
