## Construction Environmental Management Plan

#### **Project**

#### Whiting Bay Jetty

#### Scope:

To carry out repairs to damaged section of Whiting Bay Jetty. This involves overlaying a capping layer of ready mix concrete on the worst section approx 20 metres in length.

#### Method:

The area to be repaired will be required to be cleaned of all loose material and vegetation. A temporary timber shutter will be installed to retain the concrete envelope.

The work area around the site and for vehicle access will be kept to a minimum with no construction traffic outwith a designated area.

The concrete will be delivered by mixer truck to the nearest hard standing and will be transshipped into a small dumper for delivery to site.

The concrete will be placed by hand and finished off to the designated level.

On completion all timber shuttering will be removed off site and any disturbance in the surrounding area reinstated.

#### Machinery

The loose material and vegetation will be removed using a high powered water jet. This pressure washer is powered by an agricultural tractor and has its own water supply A small excavator will be used to clear sand from the face of the jetty to allow for installation of the shuttering.

A small dumper will transport materials to the site.

#### Materials

Timber Concrete Bolts(fixings) Props Concrete
