Drawings and plans will be consulted upon. If they are subject to copyright, it is the responsibility of the applicant to obtain necessary approvals to reproduce the documents and to submit suitably annotated copies with the application.

- (j) Provide a full method statement, including plan of how, when and where pontoon section(s) are proposed to be deposited and removed.
- (k) Provide assessment of the potential impacts the works may have, including interference with other uses of the sea. Please include details of areas of concern e.g designated conservation areas, such as a SAC, SPA, SSSI, MPA or Ramsar site and shellfish harvesting areas. As outlined in NPF4 Policy 3 it is necessary with the proposal that Scottish Sea Farms addresses the requirement for proposals to conserve, restore and enhance biodiversity as part of the application. We have proposed the installation of a bug hotel to provide shelter to various species of wildlife in the area.
General Policy 7 shaped the proposal from early stages. The site was chosen because it is an existing Brownfields site previously used to house feed pipes which have been removed. The pontoon is low in profile and dark coloured against a dark rocky backdrop to limit visual impact. Alternative areas were considered for the development however were found to have more impact, visually as well as environmentally as it would have required the felling of trees. The Proposal in ancillary to existing activities at the Marine farm and is required to improve safety of staff in adverse weather.
