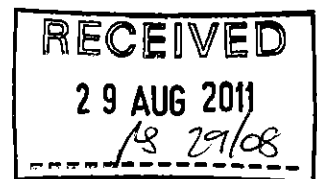

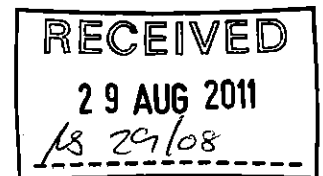
I wholeheartedly support the Scottish Government's renewable energy targets and am in favour of wind energy in appropriate areas/places.

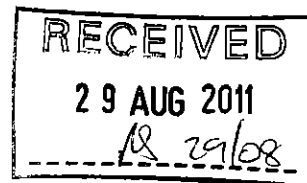
I am writing to express my support for the proposed development of 11 wind turbines off the coast at Aberdeen.

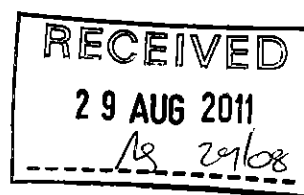

In my view the environmental and economic well-being of the nation as a whole should outweigh the selfish concerns of commercial developers whose own activities are destroying a beautiful environment.

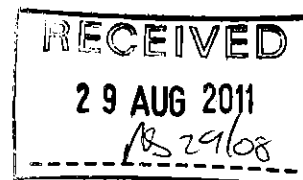

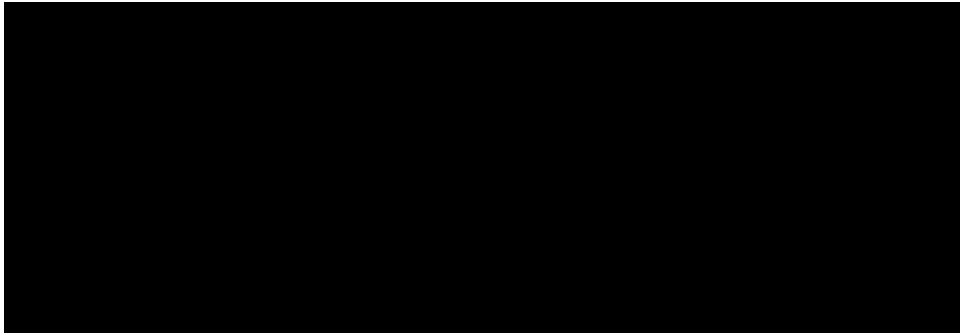
Dear Mr Ewing,

Thank you very much for your address to the British Hydro Association yesterday morning and for your clear answer to my question (about SSE / SP charging scheme). I was very pleased to hear what you had to say but would like to pick up one non-hydro related point;

Towards the end of your address you commented that you considered the Scottish Government to be one of the leading world governments in its approach to renewables (with which I agree) and committed to being incorruptible. In this light I would like to put in a plea that the Scottish Government ignores the protestations of the Trump organisation in respect of the planned offshore wind farm that may be visible from their planned golfing complex. There are of course other perfectly valid concerns about the wind farm that WW, RSPB and others have raised but the fact that the golfers can see the turbines is wholly irrelevant to the granting of permission. Indeed the threats that Mr Trump makes over the development of the site does smack of extortion and is therefore at odds with the Scottish Governments morals.

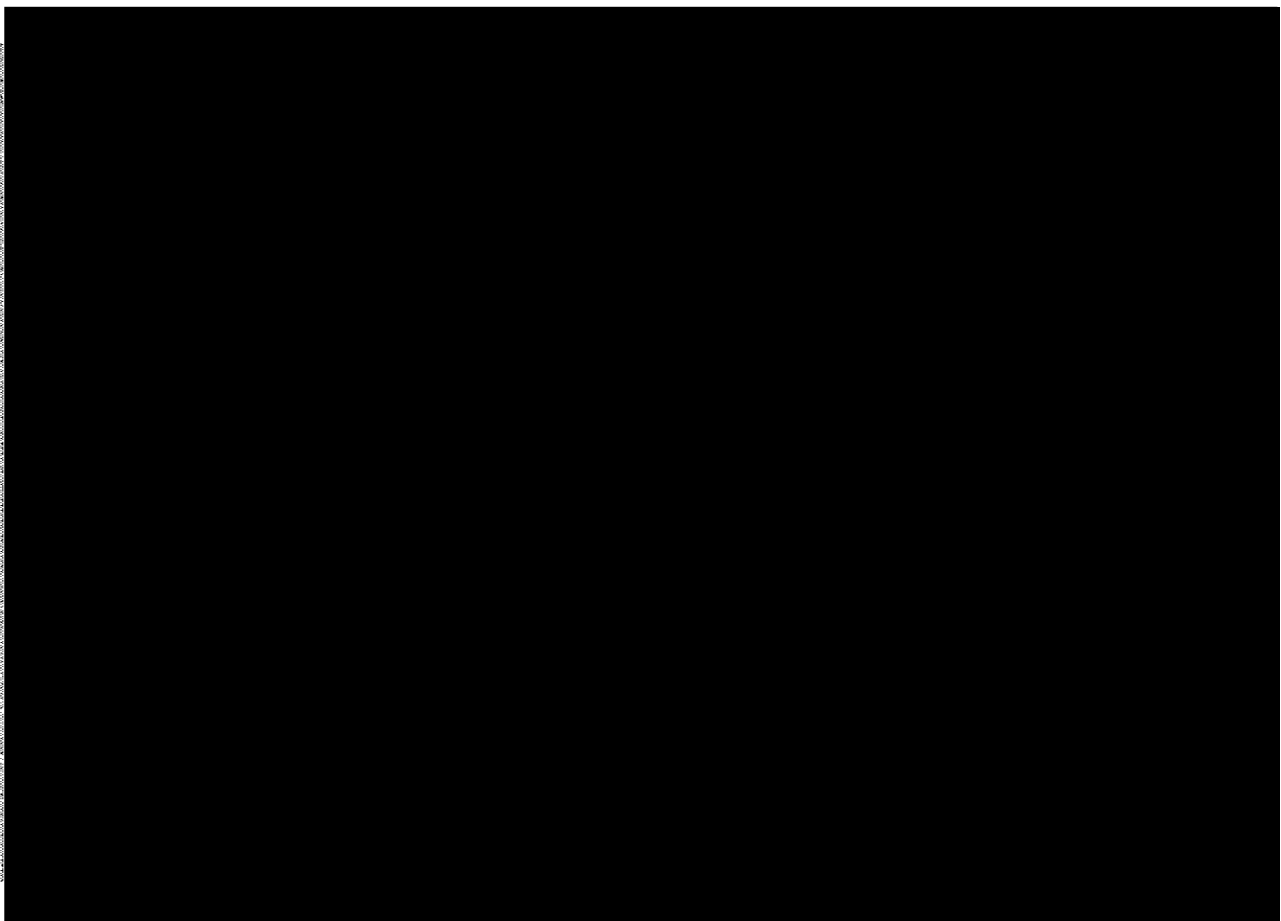
I would like to add my support to the European Offshore Wind development Centre.

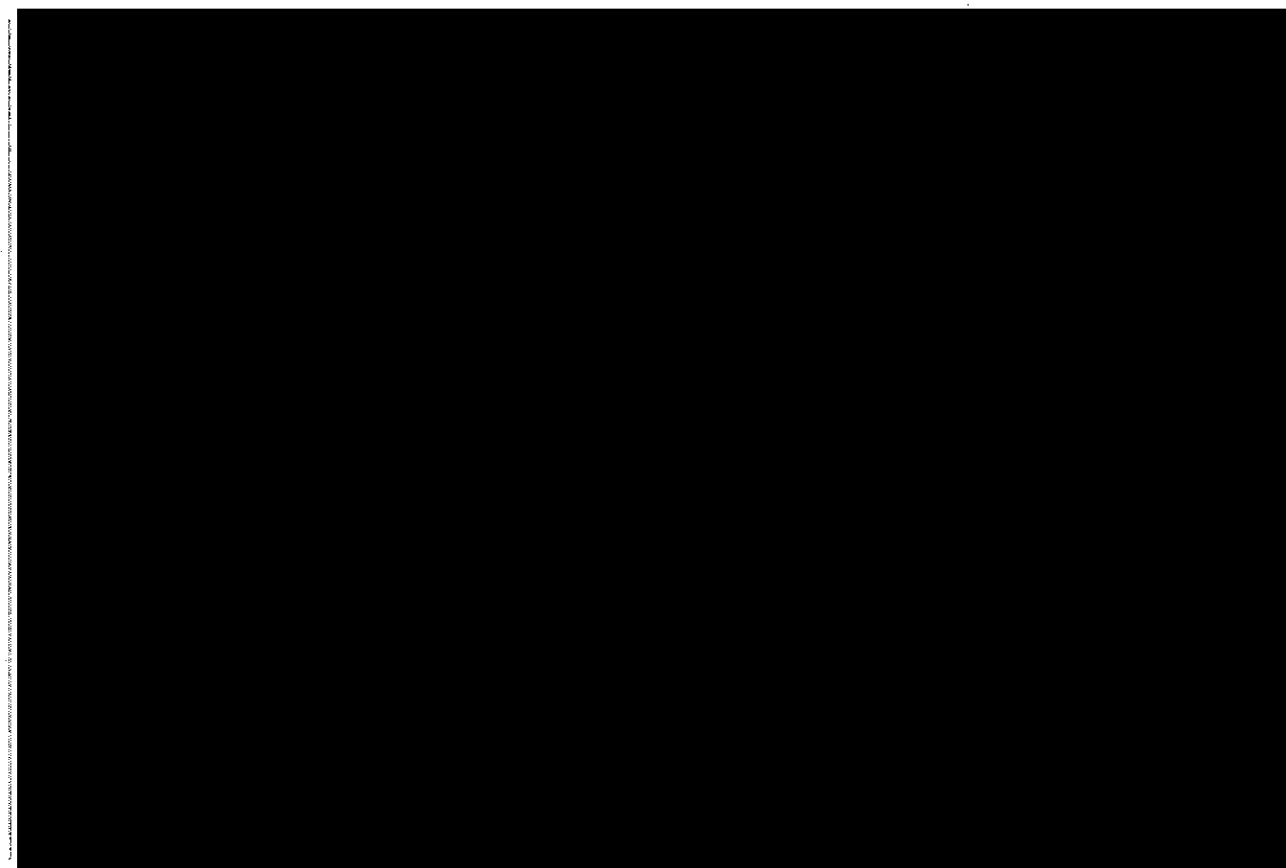
I have invested a lot of my money in recent years on land based wind farm projects, and see this as one of the ways forward for Scotland with regards to renewable energy.
