Dear Mr Salmond,

It is my understanding that Mr Trump has written to you to complain about a planning application which hopes to see some wind turbines erected along the Aberdeenshire coastline. As a Buchan resident, I wonder how it is possible that a wealthy American investor has your ear, while I do not.

For some time now, the Buchan countryside has become inundated with turbines. As this hits the Scottish governments targets on climate change and is a lucrative venture for the (mostly) farmers involved, I can understand why, although it is rapidly starting to reduce my enjoyment of the natural environment and landscape, and appears to be having a negative effect on the value of my house, too.

I do not understand, however, how it is fair that 'normal', not so famous, not so wealthy, yet hardworking people like myself seem to have but a tiny -usually unsuccessful - voice, directed towards a relatively insignificant Planning Officer, whose job it is to balance many policies and views. In contrast, Mr Trump seems to be able to skip all of that and come directly to you - as we have already observed in your intervention in his application for a resort for other rich people on a SSSI.

As you appear to be doing a sterling job as our First Minister apart from this unfortunate Trump business, I hope you will prove equally receptive to my concerns as to those of Mr Trump, and ask you kindly to - if you are intending to get involved - press the Planning Authority to approve the windfarm application that Mr Trump is objecting to. It will generate at least as much - if not more - cash and work for Scotland, give the green energy sector a boost, increase our chances of meeting carbon reduction targets, and reduce the pressure on the Aberdeenshire landscape by reducing the likelihood of more small turbines going up everywhere on the ground.

On the other hand, if you are planning to ignore Mr Trump, please feel free to ignore me too.





I have watched with dismay Mr Trump's bullying tactics over the years and not just at Menie.



I would like to take this opportunity to make my representation on the proposal to create the European Offshore Wind Deployment Centre in Aberdeen Bay.




I do hope that the Scottish Government will discount Donald Trump's opinions and rantings, preferring to make an informed and ethical decision.
