Dear Alexander

I am writing to formally notify you that Rebecca Radford of Brown and May Marine was appointed by Beatrice Offshore Wind Farm Ltd. (BOWL) as the Fisheries Liaison Officer (FLO) in order to satisfy the requirements outlined in condition 33 of the Beatrice Offshore Wind Farm Section 36 consent conditions (see overleaf).

Rebecca has been working on the project as the FLO since July 2013. Our current approach is to retain Rebecca on a yearly rolling contract. I have enclosed her C.V. for your information. Her role will include:

- Managing the Moray Firth Offshore Wind Developers Group Commercial Fisheries Working Group ("MFOWDGCFWG");
- Maintaining effective communications between the Company, its contractors or subcontractors and fishermen and other users of the sea with regard to the project;
- Ensuring that relevant stakeholders receive information relating to the safe operation of fishing activity on the wind farm site; and,
- Ensuring that all relevant project updates are communicated to the appropriate stakeholders in a timely manner.

Please can Marine Scotland confirm that this appointment is acceptable and enables the discharge of Condition 33 of the Section 36 consent.

Beatrice Offshore Wind Farm Section 36 Consent Condition 33.

Prior to the Commencement of the Development, a Fisheries Liaison Officer ("FLO"), approved by Scottish Ministers, must be appointed by the Company for the period from Commencement of the Development until the Final Commissioning of the Development. The Company must notify the Scottish Ministers of the identity and credentials of the FLO before Commencement of the Development by including such details in the EMP (referred to in condition 15). The FLO must establish and maintain effective communications between the Company, any contractors or sub-contractors, fishermen and other users of the sea during the construction of the Development, and ensure compliance with best practice guidelines whilst doing so. The responsibilities of the FLO include, but not be limited to:

- Establishing and maintaining effective communications between the Company, any contractors or sub-contractors, fishermen and other users of the sea concerning the overall project and any amendments to the CMS and site environmental procedures;
- b. Provision of information relating to the safe operation of fishing activity on the site of the Development; and
- c. Ensuring that information is made available and circulated in a timely manner to minimise interference with fishing operations and other users of the sea.

Reason: To mitigate the impact on commercial fishermen.
