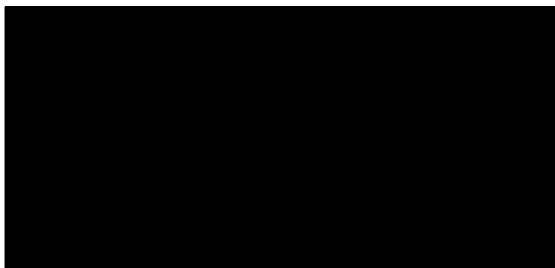
## **BOWL – BEATRICE DEVELOPMENT SPECIFICATION AND LAYOUT PLAN**

Northern Lighthouse Board are content with the proposed Development Specification and Layout Plan.

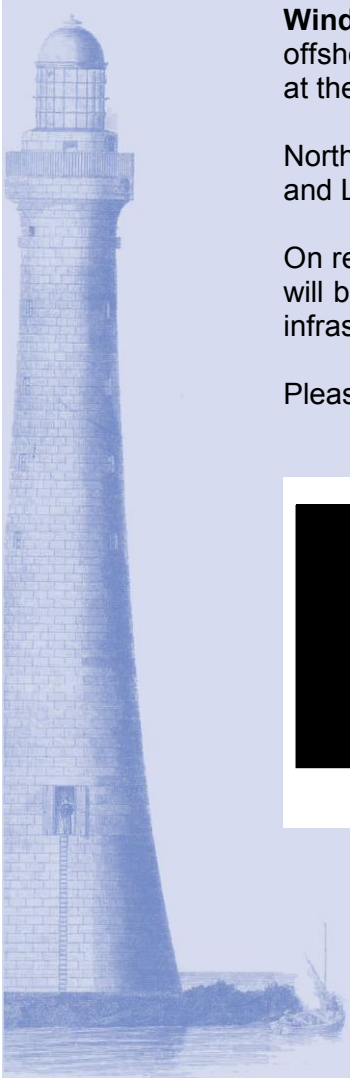

The purpose of the DSLP (OfWF) is to attempt to satisfy the requirement of condition 13 of the Beatrice Offshore Wind Farm section 36 consent awarded to BOWL in March 2014; and part of condition 3.2.2.6 of the associated BOWL Offshore Transmission Works (OfTW) marine licence issued in September 2014, as it relates to the offshore transformer modules.

#### **SSE RENEWABLES: BEATRICE, MORAY FIRTH - DSLP – MARINE SCOTLAND SCIENCE COMMENTS**

Marine Scotland Science (MSS) has reviewed the submitted document and has provided the following comments.

##### **ornithology**

MSS has no comments on ornithology.

##### **diadromous fish**

MSS has no comments on diadromous fish.

##### **commercial fisheries**

MSS has reviewed the Beatrice Development Specification and Layout Plan. Section 4.2.6 described the spacing between wind turbines. In most cases, (82 out of 84) turbines are spaced at a distance of approx. 1,170 m apart in all directions. This accommodates 50m micro-siting of wind turbines (or OTM structures) while maintaining the commercial fishing industry recommended minimum 1 km distance with adjacent structures. However, MSS note that in the case of two of the turbine locations, this will not be the case (B-D3: 945.5m to nearest turbine; and B-E1: 1065.5m to nearest turbine). We do not expect this to be a risk to navigational safety, but raise this as an issue that MS-LOT may wish to be aware of, particularly in respect of fishing operations.

There are no further comments to add to those made on 18 August in response to the consultation request on the SSE Renewables: Beatrice, Moray Firth - Environmental Management Plan, Construction Programme and Method Statement.

The Scottish Fishermen's Federation, on behalf of its members, the Anglo-Scottish Fishermen's Association, the Clyde Fishermen's Association, the Fishing Vessel Agents & Owners Association (Scotland) Limited, the Mallaig and North-West Fishermen's Association Ltd, the Orkney Fishermen's Association, Scallop Association, the Scottish Pelagic Fishermen's Association Ltd, the Scottish Whitefish Producers' Association Ltd and the Shetland Fishermen's Association who represent over 500 fishing industry businesses across Scotland is pleased to have the opportunity to respond to this Consultation.

While recognising that the potential footprint of the Beatrice windfarm development has now come down to 84 turbines as opposed to 277 the SFF notes that the planned layout was developed solely by the applicants with little input from the Commercial Fisheries Working Group (CFWG) or any part of the catching sector and thus will inevitably preclude some forms of fishing from within the boundary. This exclusion will need to be addressed in the Commercial Fisheries mitigation strategy.

Regarding Wind turbine Spacing, the SFF would note that para 4.2.5 can only refer to surface navigation and therefore it is not applicable to bottom fishing with towed gears, not does any other statement in the DSLP address this. SFF therefore awaits the outcome of the work in the CFWG attempting to mitigate the impacts of the Turbine placings.

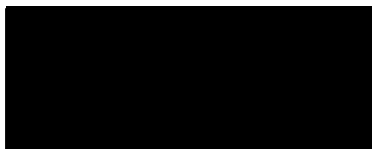

**BEATRICE OFFSHORE WIND FARM**  
**SNH & JNCC COMMENTS ON THE DEVELOPMENT SPECIFICATION & LAYOUT PLAN**

Thank you for providing us with a copy of BOWL's Development Specification and Layout Plan (DSLPL) for consultation. We have relatively few comments to make on this plan, however, please note that we are unable to provide advice on landscape and visual interests at this time. This is because the design statement is not yet available for comment and it is this document which should explain how landscape and visual impacts have been accounted for (alongside other key constraints) and mitigated as far as possible in finalising the wind farm layout.

In future, **we recommend** that MS-LOT requests the design statements for offshore wind farms to be submitted alongside the specification and layout plans.

**Landscape and Visual Interests**

It is noted in Section 1.4 and Table 1.3 (pages 11-12) that the design statement is a relevant consent plan in relation to the DSLPL, however, there is no reference to the purpose and scope of design statements either here or elsewhere in the document. We recommend that the DSLPL acknowledges the importance of landscape and visual interests (as raised in Appendix E of the SNH & JNCC response of 8 July 2013) and indicates that the design statement will address these issues and explain how they've been accounted for in finalising the wind farm layout.

In this regard, there are various publications that give further advice on the development and use of design statements:

### **Other Relevant Conditions**

Alongside the relevant consent plans discussed in the DSLP, we note that it is relevant to consider condition 5 of the Section 36 consent as this relates to the wind turbine specifications. We think it would be helpful to make reference to the discussions that have taken place between MS-LOT and BOWL over turbine selection (see MS-LOT letter dated 22 July 2014), including the collision risk modelling undertaken in support of the final choice of turbine (the Siemens SWT-7.0-154).

### **Plan Iteration**

We consider that BOWL have clearly laid out the arrangements for any required plan iteration – see Section 3 and Figure 3.1 (p14-15). We do not anticipate that there would be significant involvement from SNH or JNCC in this regard, but we have agreed with MS-LOT that they will seek our advice where relevant.

### **Benthic Interests**

In Section 4, under the discussion of key constraints (paragraphs 4.2.21 and 4.2.22), we think it would be helpful to clarify that there have been no key benthic interests recorded on-site that would need to be accounted for in the wind farm layout. In this regard, we recommend that reference is made to the results of the pre-construction sand eel survey that has been carried out and accepted by MS-LOT as a valid baseline (report dated March 2014, letter from MS-LOT dated 24 April 2015).

We would welcome clarification over any discussions that have taken place between MS-LOT and BOWL regarding micro-siting allowances (paragraph 4.2.7).

### **Constraints Mapping (Figure 4.4)**

Paragraphs 4.2.21 notes the single plugged and abandoned wellhead that lies within the proposed turbine array (and is shown on Figure 4.4). We recommend that the two further wellheads which lie within the exclusion area around the Jacky platform are also represented on Figure 4.4. If any further information is needed in this regard, it is available here:

We also think it would be helpful to improve the labelling relating to the archaeological interests discussed in paragraph 4.2.21 (and to which we think the red “HA” lettering refers).

### **Cable Protection**

It remains unclear whether or not any protection will be required in respect of the intra-array cables. In contrast to the Environmental Management Plan (please see our response of 28 August 2015), paragraph 4.7.5 of the DSLP indicates that cable protection is likely to be needed if target burial depths cannot be achieved. We note that this matter is due to be addressed in more detail in the cable plan so we will provide any required advice once this plan is submitted.

As noted, SNH will be able to provide advice on landscape and visual interests in respect of the proposed layout once the design statement and accompanying visualisations are submitted for consultation. If time allows, we would welcome a meeting with BOWL to discuss these matters (as we suggested in our response to the initial viewpoint consultation, 11 December 2014).
