Deposit of new freshwater pens and construction of 140 metre pipe, Girlsta, Shetland.

As described in application dated 10 December 2019, and correspondence submitted in support of the application.

4. Nature and quantity of all substances or objects deposited below Mean High Water Springs (hereinafter referred to as "the licensed objects"):

Part 2 - Conditions

1. The licensee must ensure that only the licensed objects listed in Part 1.4 are deposited during the execution of the licensed activities and that all substances or objects deposited during the execution of the licensed activities are inert and do not contain toxic elements which may be harmful to the marine environment, the living resources which it supports or human health.

- 2. The licensee must ensure that only the materials listed in Part 1.5 of the licence are used in the construction, alteration or improvement of works and that materials used are inert and do not contain toxic elements which may be harmful to the marine environment, the living resources which it supports or human health.
- 3. The licensee must ensure that initial deposit of the freshwater pens and the construction of the pipe must not take place between 01 June and 31 August inclusive.
- 4. The licensee must ensure that any debris or waste materials arising during the course of the licensed activities are removed from the site for disposal at an approved location above the tidal level of Mean High Water Springs.
- 5. The licensee must submit a written report regarding the correct deposit of the licensed objects listed in Part 1.4 of the licence to the licensing authority. The written report must be submitted on the forms provided by the licensing authority no later than 31 July 2021.
- 6. The licensee must submit a written report regarding the materials used during the works, as listed in Part 1.5 of the licence, to the licensing authority. The written report must be submitted on completion of the works and on the forms provided by the licensing authority no later than 31 October 2021.
- 7. The licensee must notify Source Data Receipt, The Hydrographic Office, Admiralty Way, Taunton, Somerset, TA1 2DN (e-mail: sdr@ukho.gov.uk; tel.: 01823 484444) of both progress and on completion of the licensed activities supply a copy of the licence, and wherever possible, 'as built plans', in order that all necessary amendments to nautical publications are made.
- 8. The licensee must ensure that a copy of this licence is given to each contractor appointed to carry out part or all of the licensed activities in order that they are clear about the extent of the licensed activities for which the licence has been given and the conditions that are attached to the licence.
- 9. The licensee must issue local notification to marine users including fisherman's organisations, neighbouring port authorities and other local stakeholders to ensure that they are made fully aware of the licensed activities.
- 10. The licensee must ensure appropriate steps are taken to minimise damage to the foreshore and seabed by the licensed activities.
- 11. The licensee must ensure the foreshore and seabed is returned to the original profile, or as close as reasonably practicable, following the completion of the works.
- 12. The licensee must ensure the best method of practice is used to minimise re-suspension of sediment during the works.

- 13. The licensee must ensure that the licensed objects do not encroach on any recognised anchorage, either charted or noted in nautical publications.
- 14. The licensee must ensure that:
 - a) The site is marked with a lit yellow pole fitted with a yellow 'X' topmark.
 - b) The light displays a character of flash one yellow every five seconds (FI Y 5s) with a nominal range of 2 nautical miles and be installed above the 'X' topmark.

- c) The pole is positioned at the Southeastern seaward corner of the cage group.
- d) The light is 1 metre above site equipment handrails and installed to be clearly seen by vessels approaching from all navigable directions.
- e) The pole is ≥75mm diameter, the 'X' topmark should be ≥ 75cm length by 15cm width.
- 15. The licensee must ensure that the navigation marking and lighting given in condition 14 are installed at the same time as the licensed objects and continued unless and until the licensing authority rescind this direction.
- 16. The licensee must ensure that a weekly check of the marking and lighting equipment is made and records kept of its physical state for audit purposes.
- 17. If it is desired to display any marks or lights not required by this licence then details must be submitted to the Northern Lighthouse Board and their ruling complied with. The display of unauthorised marks or lights is prohibited.
- 18. The licensee must ensure that the licensed objects and the works are maintained at all times in good repair.
- 19. The licensee must ensure that no deviation from the schedule specified in the licence is made without the further written approval of the licensing authority.
- 20. The licensee must adopt measures to prevent the introduction and spread of invasive nonnative species at and to the site.
- 21. If in the opinion of the licensing authority the assistance of a Government Department, including the broadcast of navigational warnings, is required to deal with any emergency arising from:
 - a) The failure to mark and light the licensed objects and/or the works as required by licence.
 - b) The maintenance of the licensed objects and/or the works.
 - c) The drifting or wreck of the licensed objects and/or the works.

The licensee shall be liable for any expenses incurred in securing such assistance.

22. In the event of the licensed activities being discontinued the licensed objects and the works must be removed and the site cleared to the satisfaction of the licensing authority.

23. The licensee must remove the licensed objects and/or the works from below the level of Mean High Water Springs, or such alterations made, within one month of notice being given by the licensing authority at any time it is considered necessary or advisable for the safety of navigation, and not replaced without further approval of the licensing authority. The licensee shall be liable for any expense incurred.

- 24. Any person authorised by the licensing authority must be permitted to inspect the site at any reasonable time.
- 25. The licensee must ensure that copies of the licence are available for inspection by any authorised Enforcement Officer at:
 - a) the premises of the licensee;
 - b) the premises of any agent acting on behalf of the licensee; and
 - c) the site of the licensed activities.
- 26. In the event of the licensee becoming aware that any of the information on which the issue of the licence was based has changed, the licensing authority must be immediately notified of the details.
- 27. If a new licence is required, the licensee must make an application at least fourteen weeks before the expiry date of this licence. This licence shall not continue in force after the expiry date of 21 June 2026.

NOTES

- 1. You are deemed to have satisfied yourself that there are no barriers, legal or otherwise, to the carrying out of the licensed activity. The issue of the license does not absolve the licensee from obtaining such authorisations, consents etc which may be required under any other legislation.
- 2. In the event that the licensee wishes any of the particulars set down in the Schedule to be altered, the licensing authority must be immediately notified of the alterations. It should be noted that changes can invalidate a licence, and that an application for a new licence may be necessary.
- 3. Under Section 30 of the Marine (Scotland) Act 2010, the licensing authority may vary, suspend or revoke the licence, if it appears to the licensing authority that there has been a breach of any of the provisions of the licence or for any other reason that appears to be relevant to the licensing authority.
- 4. Under Section 39 of the Marine (Scotland) Act 2010, it is an offence to carry on a licensable marine activity or cause or permit any other person to carry on such an activity without a marine licence or fails to comply with any condition of a marine licence. It is a defence for a person charged with an offence under Section 40 in relation to any activity to prove that the activity was carried out for the purpose of saving life, or for the purposes of securing the safety of a vessel, aircraft or marine structure ('force majeure'), and that the person took steps within a reasonable time to provide full details of the incident to the licensing authority. (Under Annex II, Article 7 of the Convention for the Protection of the Marine Environment of the North-East Atlantic, the licensing authority is obliged to immediately report 'force majeure' incidents to the Convention Commission).
