Part 1 - Particulars

1. Name and address of agent acting on behalf of licensee (if appropriate):

2. Location of the licensed activity (hereinafter referred to as "the site"):

Enard Bay at a point located by the coordinates:

58° 06.042' N 005° 17.336' W

As shown in Annex One.

3. Description of licensed activity:

Temporary deposit of an Acoustic Doppler Current Profiler ("ADCP")

As described in application dated 21 December 2018, and correspondence submitted in support of the application.

4. Nature and quantity of all substances or objects deposited below Mean High Water Springs (hereinafter referred to as "the licensed objects"):

Temporary Deposits

1 No. ADCP
2 No. A3 Marker buoys
2 No. Clump weights
1 No. ADCP frame

Part 2 - Conditions

1. The licensee must ensure that only the licensed objects are deposited during the execution of the licensed activity and that all substances or objects deposited during the execution of the licensed activity are inert and do not contain toxic elements which may be harmful to the marine environment, the living resources which it supports or human health.
2. The licensee must remove all licensed objects listed in Part 1 of the licence before the expiry date of this licence. **This licence shall not continue in force after the expiry date of 30 June 2020.**
3. The licensee must ensure that any debris or waste materials arising during the course of the licensed activity are removed from the site for disposal at an approved location above the tidal level of Mean High Water Springs.
4. The licensee must submit a written report regarding the correct deposit of the licensed objects to the licensing authority. The written report must be submitted on the forms provided by the licensing authority no later than 31 July 2020.
5. The licensee must ensure suitable bunding and storage facilities are employed to prevent the release of fuel oils, lubricating fluids associated with the plant and equipment into the marine environment.
6. The licensee must ensure that the A3 navigational buoys used to mark the clump weight are high visibility buoys.
7. If it is desired to display any marks or lights not required by this licence then details must be submitted to the Northern Lighthouse Board and their ruling complied with. The display of unauthorised marks or lights is prohibited.
8. The licensee must ensure that the licensed objects are maintained at all times in good repair.
9. The licensee must ensure the best method of practice is used to minimise re-suspension of sediment during the licensed activity.
10. The licensee must ensure that no deviation from the schedule specified in the licence is made without the further written approval of the licensing authority.
11. If in the opinion of the licensing authority the assistance of a Government Department, including the broadcast of navigational warnings, is required to deal with any emergency arising from:
 - a) The failure to mark and light the licensed objects as required by licence.
 - b) The maintenance of the licensed objects.
 - c) The drifting or wreck of the licensed objects.

The licensee shall be liable for any expenses incurred in securing such assistance.

12. In the event of the licensed activity being discontinued the licensed objects must be removed and the site cleared to the satisfaction of the licensing authority.

13. Any person authorised by the licensing authority must be permitted to inspect the site at any reasonable time.
14. The licensee must ensure that copies of the licence are available for inspection by any authorised Enforcement Officer at:
 - a) the premises of the licensee;
 - b) the premises of any agent acting on behalf of the licensee.
15. In the event of the licensee becoming aware that any of the information on which the issue of the licence was based has changed, the licensing authority must be immediately notified of the details.

NOTES

1. You are deemed to have satisfied yourself that there are no barriers, legal or otherwise, to the carrying out of the licensed operations. The issue of the licence does not absolve the licensee from obtaining such authorisations, consents etc which may be required under any other legislation.
2. In the event that the licensee wishes any of the particulars set down in the Schedule to be altered, the licensing authority must be immediately notified of the alterations. It should be noted that changes can invalidate a licence, and that an application for a new licence may be necessary.
3. Under Section 30 of the Marine (Scotland) Act 2010, the licensing authority may vary, suspend or revoke the licence, if it appears to the authority that there has been a breach of any of the provisions of the licence or for any other reason that appears to be relevant to the authority.
4. Under Section 39 of the Marine (Scotland) Act 2010, it is an offence to carry on a licensable marine activity or cause or permit any other person to carry on such an activity without a marine licence or fails to comply with any condition of a marine licence. It is a defence for a person charged with an offence under Section 40 in relation to any activity to prove that the activity was carried out for the purpose of saving life, or for the purposes of securing the safety of a vessel, aircraft or marine structure ('*force majeure*'), and that the person took steps within a reasonable time to provide full details of the incident to the licensing authority. (Under Annex II, Article 7 of the Convention for the Protection of the Marine Environment of the North-East Atlantic, the licensing authority is obliged to immediately report '*force majeure*' incidents to the Convention Commission).
