ASSIGNATION

between

MACCOLL OFFSHORE WIND FARM LIMITED incorporated under the Companies Acts (Registered Number 07386891) and having its Registered Office at 1st Floor, 14/18 City Road, Cardiff, CF24 3DL ("Assignor"); and

MORAY OFFSHORE WINDFARM (EAST) LIMITED incorporated under the Companies Acts (Registered Number 07101438) and having its Registered Office at C/O 7side Secretarial Limited, 1st Floor 14/18 City Road, Cardiff CF24 3DL ("Assignee")

WHEREAS:-

- (A) On 19th March 2014, the Assignor was granted consent under section 36 of the Electricity Act 1989 by the Scottish Ministers for the construction and operation of an offshore wind-powered electricity generating station known as MacColl Offshore Wind Farm located within the Eastern Development Area in the Moray Firth. On 22nd March 2018 the Scottish Ministers granted a variation of the section 36 consent. The varied section 36 consent is hereinafter referred to as "the Consent".
- (B) The Assignee wishes to assume the rights and obligations of the Assignor under the Consent and the parties to this Assignation have agreed to this upon the terms set out below.

IT IS AGREED by the parties as follows:-

1. Assignation

- 1.1 The Assignor assigns to the Assignee the Consent with effect from the last date of signing of this Assignation (the "Date of Transfer").
- 1.2 The Assignee undertakes to the Assignor to perform all the obligations of the Assignor contained or referred to in the Consent from the Date of Transfer.
- 1.3 The Assignee agrees that the Assignor is relieved of all such obligations contained or referred to in the Consent from the Date of Transfer.
- 1.4 The Assignor agrees that they are relieved of all rights arising from the Consent from the Date of Transfer and that such rights have been transferred to the Assignee with effect from the Date of Transfer.

2. Scottish Ministers' Authorisation

2.1 The parties agree that this Assignation is granted further to the letter dated 8 June 2018 from Nicola Bain at the Scottish Government to the Assignor (which letter constitutes the Scottish Ministers' prior written authorisation of the assignation of the Consent granted in accordance with condition 4 of Annex 2 of the Consent).

3. Governing law

- 3.1 The parties hereto agree that these presents shall be governed by and construed in accordance with Scots law.
- 3.2 The parties hereto consent to registration hereof for preservation
