Notice is hereby given that Dundee City Council, City Chambers, City Square, Dundee, DD1 3BY, plans to hold a pre-application consultation event regarding proposed licensable marine activity associated with the replacement of the existing pedestrian footbridge over the Dighty with a new 5.0m wide single span arch bridge (56028'30" N; 002050'12.4"W). The proposal includes the temporary and permanent works associated with excavation, piling, foundations and installation of new concrete wingwalls, abutments, and beach access steps along with reconfiguration of rock revetments to the east and west of the Dighty.
