

MARINE (SCOTLAND) ACT 2010, PART 4 MARINE LICENSING

1. PART 1 - GENERAL

1.1 Interpretation

In the licence, terms are as defined in Section 1, 64 and 157 of the Marine Scotland Act 2010, and

- a) "**the 2010 Act**" means the Marine (Scotland) Act 2010;
- b) "**Licensed Activity**" means any activity or activities listed in section 21 of the 2010 Act which is, or are authorised under the licence;
- c) "**Licensee**" means Angus Council
- d) "**Mean high water springs**" means any area submerged at mean high water spring tide;
- e) "**Commencement of the Licensed Activity**" means the date on which the first vehicle or vessel arrives on the site to begin carrying on any activities in connection with the Licensed Activity;
- f) "**Completion of the Licensed Activity**" means the date on which the Licensed Activity has been installed in full, or the Licensed Activity has been deemed complete by the Licensing Authority, whichever occurs first;

All geographical co-ordinates contained within the licence are in WGS84 format (latitude and longitude degrees and minutes to three decimal places) unless otherwise stated.

1.3 Other authorisations and consents

The Licensee is deemed to have satisfied itself that there are no barriers or restrictions, legal or otherwise, to the carrying on of the Licensed Activities in connection with the licensed activity. The issuing of the licence does not absolve the Licensee from obtaining such other authorisations and consents, which may be required under statute.

1.4 Variation, suspension, revocation and transfer

Under section 30 (1) of the 2010 Act the Licensing Authority may by notice vary, suspend or revoke the licence granted by them if it appears to the Licensing Authority that there has been a breach of any of its provisions. For any such other reason that appears to be relevant to the Licensing Authority under section 30(2) or (3) of the 2010 Act.

Under the 2010 Act variations, suspensions, revocations and transfers of licences are subject to the procedures set out in section 31 of the Act.

Under section 30 (7) of the 2010 Act, on an application made by a licensee, the Licensing Authority may vary a

licence if satisfied that the variation being applied for is not material.

Under section 30 (8) of the 2010 Act, on an application made by the licensee, the Licensing Authority may transfer the licence from the Licensee to another person.

1.5 Breach of requirement for, or conditions of, licence

Under section 39 of the 2010 Act it is an offence to carry on a Licensable Marine Activity without a marine licence and it is also an offence to fail to comply with any condition of a marine licence.

1.6 Defences: actions taken in an emergency

Under section 40 of the 2010 Act it is a defence for a person charged with an offence under section 39(1) of the 2010 Act in relation to any activity to prove that –
the activity was carried out for the purpose of saving life, or for the purpose of securing the safety of a vessel, aircraft or marine structure ('force majeure'), and
that the person took steps within a reasonable time to inform the Licensing Authority as set out in section 40(2) of the 2010 Act.

1.7 Offences relating to information

Under section 42 of the 2010 Act it is an offence for a person to make a statement which is false or misleading in a material way, knowing the statement to be false or misleading or being reckless as to whether the statement is false or misleading, or to intentionally fail to disclose any material information for the purpose of procuring the issue, variation or transfer of a marine licence or for the purpose of complying with, or purporting to comply with, any obligation imposed by either Part 4 of the 2010 Act or the provisions of this licence.

1.8 Appeals

Under Regulation 3(1) of the Marine Licensing Appeals (Scotland) Regulations 2011 a person who has applied for a marine licence may by summary application appeal to against a decision taken by the Licensing Authority under section 71(1)(b) or (c) or (5) of the Act.

2.2 Location of the Licensed Activity

ARBROATH authorised sea deposit site FO020 within a circle centred at 56° 32.000'N, 002° 32.500' W, with a radius of 0.25 nautical miles.

2.3 Description of the Licensed Activity

Deposit of maintenance dredging produced at Arbroath Harbour to be deposited at Arbroath deposit site (FO020)

As described in the application dated 10 December, 2020 and correspondence submitted in support of the application.

2.4 Descriptions of the substances or objects to be deposited

The licence authorises the deposit of the undernoted substances and objects required in connection with the licensed activity, subject to the maximum amounts as specified below:

20,640 wet tonnes to be deposited between 13 July 2022 and 12 July 2023.

20,640 wet tonnes to be deposited between 13 July 2022 and 12 July 2024.

Less any material deposited under authority of marine licence MS-00009091

3. PART 3 – CONDITIONS

3.1 General Conditions

3.1.1. The Licensee must at all times deposit substances and objects in accordance with the licence, the application and the plans and programmes approved by the Licensing Authority.

3.1.2. The Licensee must ensure that only the materials listed in Part 2 of the licence are used during the execution of the Licensed Activity and that all materials, substances or objects used during the execution of the works are inert and do not contain toxic elements which may be harmful to the marine environment, the living resources which it supports or human health.

3.1.3. Only those substances or objects described in Part 2 of the Schedule shall be deposited under authority of the licence.

a) Any unauthorised materials associated with the substances or objects scheduled for deposit, including debris such as demolition waste, wood, scrap metal, tyres and synthetic materials, shall be disposed of on land at an approved location above the tidal level of Mean High Water Springs.

b) All tank/hopper washings shall be deposited in the authorised sea deposit area(s).

3.1.4. In the event of any breach of health and safety or environmental obligations relating to the Licensed Activity during the period of the licence, the Licensee must provide written notification of the nature and timing of the incident to the Licensing Authority within 24 hours of the incident occurring. Confirmation of remedial measures taken and/or to be taken to rectify the breach must be provided, in writing, to the Licensing Authority within a period of time to be agreed by the Licensing Authority.

3.1.5. The Licensee must contact the local statutory harbour/port authority, in this case Angus Council, prior to Commencement of the Licensed Activity to discuss the requirements for navigational warnings and a works licence.

3.1.6. The Licensee must notify Source Data Receipt, The Hydrographic Office, Admiralty Way, Taunton, Somerset, TA1 2DN (e-mail: sdr@ukho.gov.uk; tel.: 01823 484444) of the progress and upon completion of the the Licensed Activity. Such notification must include a copy of the licence, and wherever possible, 'as built plans', in order that all necessary amendments to nautical publications are made.

3.1.7. Any person authorised by the Licensing Authority must be permitted to inspect the site at any reasonable time.

3.1.8 Should the Licensee proceed to undertake the Licensed Activity under the authority of the licence, the Licensed Activity authorised under the previous marine licence in favour of Angus Council, dated 21 July 2021 (licence number MS-00009091) is not permitted.

3.2 Prior to the commencement of the Licensed Activity

3.2.1. The Licensee must provide the name and function of any agent, contractor or sub-contractor appointed to undertake the Licensed Activities, as soon as is reasonably practicable prior to the Licensed Activities commencing.

3.2.2. The Licensee must, as soon as is reasonably practicable, before the Commencement of the Licensed Activity, notify the Licensing Authority, in writing, of the date of Commencement of the Licensed Activity authorised under this licence.

3.2.3. The Licensee must ensure that HM Coastguard, in this case nmoccontroller@hmcg.gov.uk, The National Maritime Operations Centre is made aware of the Licensed Activity prior to Commencement.

3.2.4. The Licensee must issue local notification to marine users – including fisherman's organisations,

neighbouring port authorities and other local stakeholders – to ensure that they are made fully aware of the Licensed Activity.

3.3 During the Licensed Activity

3.3.1. Only those persons acting on behalf of, and authorised by, the agent or the Licensee shall undertake the deposit operations.

3.3.2. The Licensee shall ensure that a log of activities is maintained on each vessel employed to undertake the deposit operations. The log(s) shall be kept onboard the vessel(s) throughout the deposit operations, and be available for inspection by any authorised Enforcement Officer. The log(s) shall be retained for a period of six calendar months following expiry of the licence, and copies of the log(s) may be requested during that period for inspection by the Licensing Authority. The log(s) shall record in English the following information:

- a) the name of the vessel;
- b) the nature and quantity of each substance or object loaded for deposit;
- c) the date and time of departure from port, and the date and time of arrival at the authorised sea deposit area(s), on each occasion that the vessel proceeds to the designated sea deposit area(s);
- d) the date, time and position of commencement, and the date, time and position of completion, of each deposit operation;
- e) the position of the vessel at regular time intervals throughout each deposit operation;
- f) the course(s) and speed(s) throughout each deposit operation. (Multiple changes may be recorded as "various");
- g) the weather, including wind strength and direction, sea-state and tidal set throughout each deposit operation;
- h) the rate of discharge during each deposit operation, if appropriate, and the duration of each deposit operation. (If the rate of discharge is not constant, the maximum and mean rates of discharge should be indicated);
- i) comments on the deposit operations, including any explanations for delays in the deposit operations;
- j) the signature of the Master at the foot of each page of the record

3.3.3. The Licensee must ensure that a copy of the licence is given to each contractor employed to undertake the licensed activities. The Licensee must also ensure that copies of the licence and all other relevant documents are available for inspection by any authorised Enforcement Officer at:

- a) the premises of the Licensee;
- b) the premises of any agent acting on behalf of the Licensee; and
- c) site of the Licensed Activity/on board the vessel(s) employed to undertake the Licensed Activities.

3.3.4. The Licensee must ensure no Licensed Activities take place within 2km of the designated Arbroath (West Links) bathing water, during the Bathing Water Season (01 June to 15 September inclusive) without prior approval of the Licensing Authority.

3.3.5. The Licensee must ensure that, if they wish to carry out Licensed Activities during the Bathing Water Season, any request for approval includes, but is not limited to;

- a) An explanation of why the proposed Licensed Activities must take place during the Bathing Water Season;
- b) A plan detailing how Marine Scotland Licensing Operations Team and Scottish Environment Protection Agency will be notified of the start and completion of the Licensed Activity; and
- c) A method statement indicating the location, type and amount of material to be dredged, dredging technique to be used, the method of deposit and any mitigation measures.

3.3.6. The Licensee must ensure that a dedicated watch must be kept by an appropriately briefed crew member

acting as a Marine Mammal Observer (MMO) and any watch should commence 20 minutes before deposit.

3.3.7. The Licensee must ensure that no deposit takes place if a marine mammal is sighted within 200m of the deposit site. If marine mammals are observed within the observation area of 200m around the deposit site, then deposit should not commence until the area has been clear for five minutes.

3.3.8. The Licensee must deposit the substances or objects described in Part 2 of the Marine Licence in the following authorised sea deposit area(s):

Arbroath Deposit Site, FO020 : Up to a maximum quantity of 20,640 Wet Tonnes may be deposited during the period of validity of the licence, within the area of a circle, radius of 0.25 nautical miles, centred at point 56° 32.000' N, 002° 32.500' W.

3.4 Upon Completion of the Licensed Activity

3.4.1. The Licensee must submit written reports to the Licensing Authority stating the nature and total quantity, in wet tonnes, of all substances or objects deposited under authority of the licence. The written reports must be submitted to the licensing authority annually and on the forms provided by the Licensing Authority.

3.4.2. The Licensee must, no later than 14 days following the Completion of the Licensed Activity notify the Licensing Authority, in writing, of the date of the Completion of the Licensed Activity.
