If a project will not be completed before a marine licence lapses, it will be necessary for licence holders to re-apply for a further licence to continue any ongoing work at least 14 weeks prior to the expiry date of the licence. Target duration for determination of a marine licence application is 14 weeks.

- (e) Provide the cost of the works seawards of the tidal limit of MHWS. This estimate should only cover



work taking place below the tidal level of MHWS and must take into consideration the cost of materials, labour fees etc.

WGS84 is the World Geodetic System 1984 and the reference co-ordinate system used for marine licence applications. Co-ordinates taken from GPS equipment should be set to WGS84. In a few cases, (e.g. laying of long pipelines) it may only be practicable to supply co-ordinates for the start and end points.

Drawings and plans will be consulted upon. If they are subject to copyright, it is the responsibility of the applicant to obtain necessary approvals to reproduce the documents and to submit suitably annotated copies with the application.

Sewer outfalls, discharge pipes for industrial waste etc. The size and description of the pipe must be shown on the longitudinal sections and also details of its supports, foundations, methods of jointing and details of any tidal flaps.

Bridges over tidal waters: An elevation with longitudinal and cross-sections of the bridge to a suitable scale must show the dimensions of the spans and width of piers, etc. above and below MHWS and the maximum and minimum heights of the undersides of the superstructures above MHWS. The headroom above MHWS and the width of span of the nearest bridges, if any, above and below the site must be stated.

Tunnels under tidal waters: The longitudinal section of the tunnel must show the distances between the bed of the river or estuary and the top of the tunnels. Cross-sections must show the internal and external dimensions of the tunnel and particulars of construction. When a proposed future dredging level is known this must also be shown on all sections.

Overhead cables: Catenary must be supplied in addition to the site plan showing the minimum clearance of the cable at MHWS and the electrical clearance allowed.

(h) Method statement including schedule of work (continue on separate sheet if necessary):

The proposed closure bund is to be placed within/across this waterway/channel. Below the M.H.W.S level it will be formed generally from granular materials with coarser materials used predominantly where there is an increased rsk of materials becoming washed out. A small proportion of fine materials such as silts or clays will be placed in the inner infill zones and above M.H.W.S. Courser materials will have a nominal fines content. Ground investigations have confirmed a thickness of around 1.75m to 2.0m of seabed silts , which will be left largely undisturbed and intact with stone punched and pushed into this seabed layer, before infilling above this with coarse granular fill. Material will be placed above the seabed by a combination of excavator or "grab" buckets and controlled end-tipped directly into the area of deposition. This process will continue until the level of M.H.W.S is reached, above which other materials may then be used. Following construction of the infill bund to access road information level, the revetment secondary and then primary rock armour will be placed in accordance with the design requirements as outlined on the constrictions drawings.

Drawing 72637Z-121 shows the proposed bridge infill works

Photographs DCN0072 and DSCN0099 show the existing bridge that is to be removed and the location of the proposed causeway.

(i) Potential impacts the works may have (including details of areas of concern e.g designated conservation and shellfish harvesting areas) and proposed mitigation in response to potential impacts (continue on separate sheet if necessary):

None anticipated in the immediate vicinity of the area of works on either side if the waterway/ channel, to be closed off and infilled. Whilst there will be some limited disturbance to the in-situ seabed silts during placement of the infill materials, it is not proposed to remove them from the seabed to the surface as this would cause an increased level of disturbance. The materials to be placed will comprise generally coarser granular materials with nominal fines (silt/clay particle sized materials) which could more easily become water-bore, with silt/clay only used within the inner infill zones and above H.M.W.S.

The closest designated site is approximately less than 1kn from the site as shown in drawing 72637/WS/0002.
