Moray Offshore Renewables Limited (Telford Offshore Wind Farm, Stevenson Offshore Wind Farm and MacColl Offshore Wind Farm formerly MORL, now Moray Offshore Windfarm (East) Limited "Moray East")

Section 36 Consents (as varied): Condition 20

Thank you for your correspondence dated 8 November 2018 stating that a Radar Mitigation Scheme Agreement ("RMS Agreement") had been entered into by Moray Offshore Windfarm (East) Limited ("Moray East") and the Ministry of Defence ("MOD") which constitutes the Air Traffic Control Radar Mitigation Scheme ("ATC Scheme"). In this letter you requested that Marine Scotland Licensing Operations Team ("MS-LOT") confirm the suitability of the ATC Scheme for approval by the Scottish Ministers in accordance with the requirements of Condition 20 of the Section 36 Consents for the MacColl Offshore Windfarm, Stevenson Offshore Windfarm and Telford Offshore Windfarm granted to Moray East to construct and operate the above-named wind farms ("the s.36 Consents"), together referred to as "Moray East Offshore Wind Farm".

On 11 December 2018, MS-LOT received a letter from the Defence Infrastructure Organisation ("DIO"), on behalf of the MOD. The letter confirmed that a Radar Mitigation Scheme Agreement ("RMS Agreement") has been entered into between Moray East and the MOD dated 11 September 2018 in relation to the identification, trialling and implementation of a mitigation solution in respect of the Moray East Offshore Wind Farm.







The letter, also states that the MOD considers that the RMS Agreement in respect of the Moray East Offshore Wind Farm can be regarded as the ATC Scheme specified under condition 20 of the s.36 Consents.

The letter also confirms that the RMS Agreement comprising the ATC Scheme in respect of the Moray East Offshore Wind Farm is suitable for approval by the Scottish Ministers in accordance with the requirements of the s.36 Consents.

MS-LOT is therefore satisfied and gives its approval to the ATC Scheme entered into through the RMS agreement between Moray East and MOD. This approval is subject to Moray East's compliance with the terms of the RMS agreement and parts a-c of condition 20.
