As previously identified the proposed development will give rise to some potentially significant impacts on Angus Council's administrative area. The assessment for the purposes of the current consultation will focus on any changes arising from the proposed variations to the scheme for the material considerations identified by Angus Council in the original consultation, which are:

- 1. Seascape, Landscape and Visual Impacts;
- 2. Cumulative Seascape, Landscape and Visual impacts
- 3. Impact on Cultural Heritage.

# Seascape, Landscape and Visual Impacts

Chapter 14 of the Environmental Impact Assessment Report assesses Seascape, Landscape and Visual Impacts (including cumulative effects). This undertakes an assessment of the 'worst case' design scenario and considers the effects of installing 54 turbines with a hub height of 126m above LAT, a maximum blade tip height of 208m above LAT and a maximum rotor diameter of 167m. It is considered that this assessment captures the potential effects associated with the proposed turbine specification sought when compared to the consented project, and the associated impact, would not be any greater than that predicted in the EIA Report.

Whilst the development proposes to reduce overall number of turbines the respective increase in tip height and rotor diameter will invariably make the individual turbines more visible. It is considered that there would be significant impacts upon landscape and seascape character however these are not considered to be unacceptable. In relation to visual impacts notwithstanding the separation distances from Angus to the proposed development the turbines will result in a significant visual impact. Notwithstanding this, the findings of the ES are considered to be accurate; the visual impact on Angus is not considered to be unacceptable.

This Authority previously highlighted concerns in its consultation to the original proposal regarding the lighting of the windfarm for both shipping navigation and aviation. It is evident that this matter has been assessed in greater detail in the EIA

Report although it is highlighted that there are limitations to this assessment. The night time viewpoints confirm that the lighting would be viewed in close association and at a similar height to the light on the Bell Rock Lighthouse. Such a scenario would result in significant impacts on the setting of the lighthouse. It is evident from the visualisations that lighting both aviation and navigation would have significant night seascape impacts. Further consideration requires to be given to this matter in order to ensure an appropriate technical solution is identified and if this is the case the associated effects would be unlikely to be unacceptable.

# Cumulative Seascape, Landscape and Visual Impacts

In relation to cumulative impacts the EIA Report at Chapter 14 identifies the 'worst case' design scenario for the other offshore windfarm developments as those presented in the Scoping Reports submitted to Marine Scotland for the respective developments which assume a smaller number of larger turbines. Such an approach to the cumulative assessment appears logical as it seems unlikely the consented projects will now be constructed.

Our concerns in relation to cumulative impacts remain as previously expressed in our consultation to the original proposal. We would stress that a key cumulative consideration is the relative height and design of the three different off-shore windfarm developments. A level of consistency is important to prevent the collective view becoming visually inconsistent or distorting seascape perspective by for example having turbines of noticeably different sizes within the same view. The proposal for Neart Na Gaoithe proposes the use of 208m high turbines (blade tip). Despite their distance from Angus, their size gives rise to significant visual impacts. Although this proposal is not unacceptable, the replicating of turbines of this size or at a greater size much closer to Angus and the Bell Rock Lighthouse as part of future applications may not be considered acceptable and design options available may become limited if this application is approved at 208m. It is also considered that overly broad "Rochdale Envelopes" could lead to significant differences in size and proportion of turbines between different developments or within individual developments.

It is also relevant for consideration to be given to the cumulative impacts associated with the lighting of the proposed developments. The presence of three developments will result in them being viewed alongside or in front of each other typically extending the extent of horizon effected by aviation lighting. There will also be lights in front of lights along some parts of the horizon which will significantly increase night time impacts of the developments. The lighting will likely be visible in prominent views from long distances across Angus with navigation lighting likely to be visible from higher ground which will further increase the cumulative impacts of the developments. The Bell Rock Lighthouse would be typically viewed within the same part of the horizon which would contain the turbine lighting which would significantly erode the presence of this landmark in the seascape. Further consideration requires to be given to the lighting of the developments in order to ensure a consistent lighting solution is identified and to identify methods to mitigate adverse impacts.

### Impact on Cultural Heritage

Chapter 13 of the EIA Report assesses the potential impacts on cultural heritage interests resulting from the construction and operation of the wind farm in a worst case scenario. Historic Environment Scotland notes the presence of nationally important designated cultural heritage assets within the vicinity of the development – such as Bell Rock Lighthouse and Ladyloan Signal Tower, Arbroath. They are content that the impact does not raise issues of national significance. However, we consider that this impact is likely to be higher than the 'minor' value assigned to it for both setting impacts and cumulative impacts.

Angus Council has previously expressed its concerns regarding the impact of the development on the Bell Rock Lighthouse and would concur with the assessment of Historic Environment Scotland but would highlight that the EIA Report does still have limitations in terms of assessing impacts of aviation and navigation lighting on the setting of the asset.

### Conclusion

It is concluded that the impacts of the proposed Neart Na Gaoithe offshore wind farm, in terms of material considerations relevant to Angus Council administrative area, do not raise any new or significant issues. The comments provided previously by Angus Council on the original Section 36 application and subsequent variation still, to some extent, remain relevant. Angus Council does not object to this application.

I refer to your email of 10 January 2019 seeking our inviting representations on the above.

The application seeks

- 1. Removal of reference to transmission infrastructure (i.e. offshore substation platforms, interconnector cables and offshore export cables) from the Description of the Development in Annex 1 and from conditions 12 and 22 of Annex 2;
- 2. Amendment of minimum blade tip clearance from 35 to 36m (measured from LAT) and
- 3. Amendment of blade width in Annex 2 from 4.5m to 5.5m.

As regards (1) above: the Council notes that if the offshore substation platforms, interconnector cables and export cables are removed from consent, then the conditions of the Section 36 consent which apply to those elements will no longer apply. The Council notes that the Marine Licence does not appear to contain a condition requiring consultation of East Lothian Council on the layout plan, which would include the location of the substation platforms. This could potentially be of interest to the Council, especially if they are to be lit. It appears the Council would also not be consulted on the Operation and Maintenance Programme as regards these elements (condition 16 of the Section 36 consent). As activities are in some cases immediately offshore or even on the East Lothian Coast, the Council would prefer to be consulted. The Council is not certain if any elements of (1) above are relevant to the Fisheries Management Strategy (Section 36 condition 25) the Construction Traffic Management Plan (Condition 29) but if so this should also be considered as it does not appear to be included in the Marine Licence conditions.

Our main concern is however Condition 20 of the Section 36 consent which concerns the Lighting and Marking Plan, on which the Council is to be consulted. This is not replicated in the Marine Licence conditions. Although there is reference in the Marine Licence to a Lighting and Marking Plan, there is no mention of consultation of the Council on this. The Council is concerned to keep visibility of lighting from East Lothian of the project as a whole to the minimum required, and would therefore request consultation over the lighting of the parts of the project removed from the Section 36 consent.





As regards (2) and (3) above, the Council notes that it is not expected that at the distance East Lothian is from the project, that the difference in blade width will be perceptible, and that this is within the parameters assessed through EIA. The Council does not therefore anticipate any noticeable additional effects on landscape or seascape from this change.

The Council values its birdlife, including that of the Firth of Forth SPA, the Forth Islands SPA, and that of the Outer Firth of Forth and St Andrews Bay Complex proposed marine SPA. The Council does not support development that would have an adverse impact on the integrity of European sites within East Lothian, or involving such an effect on qualifying interest species of sites outwith East Lothian that visit East Lothian or its coast. Scottish Natural Heritage have expertise in this area. Provided that SNH do not consider that if there is an adverse effect on the integrity of any such Natura 2000 site or species either of this scheme alone, cumulatively or in-combination, that this is no worse than the currently consented scheme, the Council does not object on this ground.

#### Conclusion

The Council therefore **objects** to (1) above unless conditions can be added to the Marine Licence or through other means to ensure that the Council is consulted over the Lighting and Marking Plan as regards the elements removed.

The Council would also prefer to be consulted over the layout plan and the Operation and Maintenance Programme. The Council does not object to (2) or (3) provided SNH are content that any adverse effects on the integrity of a Natura 2000 sites within or adjacent to East Lothian, or where the qualifying interests visit the East Lothian or the coast off East Lothian, are no worse than the currently consented scheme.

It appears the Council would also not be consulted on the Operation and Maintenance Programme as regards these elements (condition 16 of the Section 36 consent). As activities are in some cases immediately offshore or even on the East Lothian Coast, the Council would prefer to be consulted. The Council is not certain if any elements of (1) above are relevant to the Fisheries Management Strategy (Section 36 condition 25) the Construction Traffic Management Plan (Condition 29) but if so this should also be considered as it does not appear to be included in the Marine Licence conditions.

Our main concern is however Condition 20 of the Section 36 consent which concerns the Lighting and Marking Plan, on which the Council is to be consulted. This is not replicated in the Marine Licence conditions. Although there is reference in the Marine Licence to a Lighting and Marking Plan, there is no mention of consultation of the Council on this. The Council is concerned to keep visibility of lighting from East Lothian of the project as a whole to the minimum required, and would therefore request consultation over the lighting of the parts of the project removed from the Section 36 consent.





As regards (2) and (3) above, the Council notes that it is not expected that at the distance East Lothian is from the project, that the difference in blade width will be perceptible, and that this is within the parameters assessed through EIA. The Council does not therefore anticipate any noticeable additional effects on landscape or seascape from this change.

The Council values its birdlife, including that of the Firth of Forth SPA, the Forth Islands SPA, and that of the Outer Firth of Forth and St Andrews Bay Complex proposed marine SPA. The Council does not support development that would have an adverse impact on the integrity of European sites within East Lothian, or involving such an effect on qualifying interest species of sites outwith East Lothian that visit East Lothian or its coast. Scottish Natural Heritage have expertise in this area. Provided that SNH do not consider that if there is an adverse effect on the integrity of any such Natura 2000 site or species either of this scheme alone, cumulatively or in-combination, that this is no worse than the currently consented scheme, the Council does not object on this ground.

#### Conclusion

The Council therefore **objects** to (1) above unless conditions can be added to the Marine Licence or through other means to ensure that the Council is consulted over the Lighting and Marking Plan as regards the elements removed.

The Council would also prefer to be consulted over the layout plan and the Operation and Maintenance Programme. The Council does not object to (2) or (3) provided SNH are content that any adverse effects on the integrity of a Natura 2000 sites within or adjacent to East Lothian, or where the qualifying interests visit the East Lothian or the coast off East Lothian, are no worse than the currently consented scheme.

I have now found the relevant document and I do have a question regarding the removal of the following aspects in blue:

Up to 54 jacket foundations and ancillary equipment.

- 3. Up to 2 Offshore Substation Platforms ("OSPs"), jacket foundations and ancillary equipment.
- 4.3. Up to 140km of inter-array cabling. and up to 4 interconnector cables between the 2 OSPs.
- 5. Two subsea Offshore Export Cables ("OEC") each of up to 43km in length;
- 6.4. scour and cable protection.
- 7.5. A Meteorological mast.

Does this mean the OSPs, the interconnector cables between the OSPs and the two subsea OEC are being removed from the design completely? If so, I don't see any impact on the safety of navigation by removing these from scope as the worst case scenario would have been assessed in the NRA. This is on the understanding that there are no other parameters being changed as a result which could affect the outcome of the NRA from the safety of navigation and search and rescue perspective.

I also don't have any issue with regards to the changes to maximum blade width.

Thank-you for the opportunity to comment on the Application to Vary the Section 36 Consent for the Neart Na Gaoithe Offshore Wind Development.

Whilst the variation is predicted to marginally reduce the overall impact on seabird populations, especially gannet, kittiwake and herring gull, we remain concerned about the overall level of impact on seabird populations; especially as some of the species most affected are already experiencing significant population declines. The Neart Na Gaoithe development directly, and in combination with Inch Cape and Seagreen, is likely to have a significant effect on the integrity of a number of internationally important Special Protection Areas in the Firth of Forth.

We would like to stress again the importance of having a robust Environmental Management Plan in place which ensures that the monitoring of these impacts is continually assessed during construction and operation and that enables mitigation (including shut-down) to be taken as appropriate.

Wildlife tourism is well established in this part of Scotland and brings with it important socio-economic benefits and opportunities to provide information to the public on offshore windfarm developments. The Scottish Seabird Centre, which attracts 270,000 visitors a year, remain willing to engage with any organisation to help present impartial information that helps people to take an informed view about these offshore wind developments.



The consultation request dated 10<sup>th</sup> January 2019 associated with the above application has been passed to Jacobs in their capacity as Development Planning Advisor and Auditor to Transport Scotland. The comments below refer to the documentation provided in support of the above application submitted on 8<sup>th</sup> January 2019. Transport Scotland would highlight their previously issued responses, dated 21st September 2015, 5th July 2017, 1st May 2018 and 20th August 2018, and advise that these are referenced.

Transport Scotland would advise that the proposed variations in consent are not considered likely to result in any detrimental impact to the trunk road network. As such, no further comments are advised at this time. However, Transport Scotland would reiterate the conditions advised in their response dated 1<sup>st</sup> May 2018, which are detailed below for reference, and advise that the proposed variations should be considered in satisfying the requirements set out in these conditions.

1. Development shall not commence until a Construction Traffic Management Plan has been approved in writing by the Consenting Authority in consultation with Transport Scotland. Thereafter, all construction traffic associated with the development shall conform to the requirements of the agreed plan.

Reason: To maintain safety for both the trunk road traffic and the traffic moving to and from the development.

2. The proposed route for any abnormal loads on the trunk road network must be approved by the trunk roads authority prior to the movement of any abnormal load. Any accommodation measures required including the removal of street furniture, junction widening, or traffic management must similarly be approved.

Reason: To ensure that the transportation of abnormal loads will not have any detrimental effect on the trunk road network.

3. Any additional signing or temporary traffic control measures deemed necessary due to the size or length of loads being delivered must be undertaken by a recognised Quality Assured traffic management consultant, to be approved by the trunk road authority before delivery commences.

Reason: To minimise interference with the safety and free flow of the traffic on the trunk road.

### **Background Information**

VisitScotland, as Scotland's National Tourism Organisation, has a strategic role to develop Scottish tourism in order to get the maximum economic benefit for the country. It exists to support the development of the tourism industry in Scotland and to market Scotland as a quality destination.

While VisitScotland understands and appreciates the importance of renewable energy, tourism is crucial to Scotland's economic and cultural well-being. It sustains a great diversity of businesses throughout the country. According to a recent independent report by Deloitte, tourism generates £11 billion for the economy and employs over 200,000 - 9% of the Scottish workforce. Tourism provides jobs in the private sector and stimulates the regeneration of urban and rural areas.

One of the Scottish Government and VisitScotland's key ambitions is to grow tourism revenues and make Scotland one of the world's foremost tourist destinations. This ambition is now common currency in both public and private sectors in Scotland, and the expectations of businesses on the ground have been raised as to how they might contribute to and benefit from such growth.

### <u>Importance of scenery to tourism</u>

Scenery and the natural environment have become the two most important factors for visitors in recent years when choosing a holiday location.

The importance of this element to tourism in Scotland cannot be underestimated. The character and visual amenity value of Scotland's landscapes is a key driver of our tourism product: a large majority of visitors to Scotland come because of the landscape, scenery and the wider environment, which supports important visitor activities such as walking, cycling wildlife watching and visiting historic sites.

The VisitScotland Visitor Experience Survey (2015/16) confirms the basis of this argument with its ranking of the key factors influencing visitors when choosing Scotland as a holiday location. In this



study, over half of visitors rated scenery and the natural environment as the main reason for visiting Scotland. Full details of the Visitor Experience Survey can be found on the organisation's corporate website, here:

### Taking tourism considerations into account

We would suggest that full consideration is also given to the Scottish Government's 2008 research on the impact of wind farms on tourism. In its report, you can find recommendations for planning authorities which could help to minimise any negative effects of wind farms on the tourism industry. The report also highlights a request, as part of the planning process, to provide a tourism impact statement as part of the Environmental Impact Analysis. Planning authorities should also consider the following factors to ensure that any adverse local impacts on tourism are minimised:

- The number of tourists travelling past en route elsewhere
- The views from accommodation in the area
- The relative scale of tourism impact i.e. local and national
- The potential positives associated with the development
- The views of tourist organisations, i.e. local tourist businesses or VisitScotland

### Conclusion

Given the aforementioned importance of Scottish tourism to the economy, and of Scotland's landscape in attracting visitors to Scotland, VisitScotland would strongly recommend any potential detrimental impact of the proposed development on tourism - whether visually, environmentally and economically - be identified and considered in full. This includes when taking decisions over turbine height and number.

VisitScotland strongly agrees with the advice of the Scottish Government –the importance of tourism impact statements should not be diminished, and that, for each site considered, an independent tourism impact assessment should be carried out. This assessment should be geographically sensitive and should consider the potential impact on any tourism offerings in the vicinity.

VisitScotland would also urge consideration of the specific concerns raised above relating to the impact any perceived proliferation of developments may have on the local tourism industry, and therefore the local economy.

I have now found the relevant document and I do have a question regarding the removal of the following aspects in blue:

Up to 54 jacket foundations and ancillary equipment.

- 3. Up to 2 Offshore Substation Platforms ("OSPs"), jacket foundations and ancillary equipment.
- 4.3. Up to 140km of inter-array cabling. and up to 4 interconnector cables between the 2 OSPs.
- 5. Two subsea Offshore Export Cables ("OEC") each of up to 43km in length;
- 6.4. scour and cable protection.
- 7.5. A Meteorological mast.

Does this mean the OSPs, the interconnector cables between the OSPs and the two subsea OEC are being removed from the design completely? If so, I don't see any impact on the safety of navigation by removing these from scope as the worst case scenario would have been assessed in the NRA. This is on the understanding that there are no other parameters being changed as a result which could affect the outcome of the NRA from the safety of navigation and search and rescue perspective.

I also don't have any issue with regards to the changes to maximum blade width.

## Proposed revised Neart na Gaoithe Offshore Wind Farm development, Firth of Forth

Thank you for giving VisitScotland the opportunity to comment on the above wind farm development.

Our response focuses on the crucial importance of tourism to Scotland's local and national economy, and of the natural landscape for visitors.

## **Background Information**

VisitScotland, as Scotland's National Tourism Organisation, has a strategic role to develop Scottish tourism in order to get the maximum economic benefit for the country. It exists to support the development of the tourism industry in Scotland and to market Scotland as a quality destination.

While VisitScotland understands and appreciates the importance of renewable energy, tourism is crucial to Scotland's economic and cultural well-being. It sustains a great diversity of businesses throughout the country. According to a recent independent report by Deloitte, tourism generates £11 billion for the economy and employs over 200,000 - 9% of the Scottish workforce. Tourism provides jobs in the private sector and stimulates the regeneration of urban and rural areas.

One of the Scottish Government and VisitScotland's key ambitions is to grow tourism revenues and make Scotland one of the world's foremost tourist destinations. This ambition is now common currency in both public and private sectors in Scotland, and the expectations of businesses on the ground have been raised as to how they might contribute to and benefit from such growth.

### <u>Importance of scenery to tourism</u>

Scenery and the natural environment have become the two most important factors for visitors in recent years when choosing a holiday location.

The importance of this element to tourism in Scotland cannot be underestimated. The character and visual amenity value of Scotland's landscapes is a key driver of our tourism product: a large majority of visitors to Scotland come because of the landscape, scenery and the wider environment, which supports important visitor activities such as walking, cycling wildlife watching and visiting historic sites.

The VisitScotland Visitor Experience Survey (2015/16) confirms the basis of this argument with its ranking of the key factors influencing visitors when choosing Scotland as a holiday location. In this



study, over half of visitors rated scenery and the natural environment as the main reason for visiting Scotland. Full details of the Visitor Experience Survey can be found on the organisation's corporate website, here:

### Taking tourism considerations into account

We would suggest that full consideration is also given to the Scottish Government's 2008 research on the impact of wind farms on tourism. In its report, you can find recommendations for planning authorities which could help to minimise any negative effects of wind farms on the tourism industry. The report also highlights a request, as part of the planning process, to provide a tourism impact statement as part of the Environmental Impact Analysis. Planning authorities should also consider the following factors to ensure that any adverse local impacts on tourism are minimised:

- The number of tourists travelling past en route elsewhere
- The views from accommodation in the area
- The relative scale of tourism impact i.e. local and national
- The potential positives associated with the development
- The views of tourist organisations, i.e. local tourist businesses or VisitScotland

## Conclusion

Given the aforementioned importance of Scottish tourism to the economy, and of Scotland's landscape in attracting visitors to Scotland, VisitScotland would strongly recommend any potential detrimental impact of the proposed development on tourism - whether visually, environmentally and economically - be identified and considered in full. This includes when taking decisions over turbine height and number.

VisitScotland strongly agrees with the advice of the Scottish Government –the importance of tourism impact statements should not be diminished, and that, for each site considered, an independent tourism impact assessment should be carried out. This assessment should be geographically sensitive and should consider the potential impact on any tourism offerings in the vicinity.

VisitScotland would also urge consideration of the specific concerns raised above relating to the impact any perceived proliferation of developments may have on the local tourism industry, and therefore the local economy.

The consultation request dated 10<sup>th</sup> January 2019 associated with the above application has been passed to Jacobs in their capacity as Development Planning Advisor and Auditor to Transport Scotland. The comments below refer to the documentation provided in support of the above application submitted on 8<sup>th</sup> January 2019. Transport Scotland would highlight their previously issued responses, dated 21st September 2015, 5th July 2017, 1st May 2018 and 20th August 2018, and advise that these are referenced.

Transport Scotland would advise that the proposed variations in consent are not considered likely to result in any detrimental impact to the trunk road network. As such, no further comments are advised at this time. However, Transport Scotland would reiterate the conditions advised in their response dated 1<sup>st</sup> May 2018, which are detailed below for reference, and advise that the proposed variations should be considered in satisfying the requirements set out in these conditions.

1. Development shall not commence until a Construction Traffic Management Plan has been approved in writing by the Consenting Authority in consultation with Transport Scotland. Thereafter, all construction traffic associated with the development shall conform to the requirements of the agreed plan.

Reason: To maintain safety for both the trunk road traffic and the traffic moving to and from the development.

2. The proposed route for any abnormal loads on the trunk road network must be approved by the trunk roads authority prior to the movement of any abnormal load. Any accommodation measures required including the removal of street furniture, junction widening, or traffic management must similarly be approved.

Reason: To ensure that the transportation of abnormal loads will not have any detrimental effect on the trunk road network.

3. Any additional signing or temporary traffic control measures deemed necessary due to the size or length of loads being delivered must be undertaken by a recognised Quality Assured traffic management consultant, to be approved by the trunk road authority before delivery commences.

Reason: To minimise interference with the safety and free flow of the traffic on the trunk road.

Thank-you for the opportunity to comment on the Application to Vary the Section 36 Consent for the Neart Na Gaoithe Offshore Wind Development.

Whilst the variation is predicted to marginally reduce the overall impact on seabird populations, especially gannet, kittiwake and herring gull, we remain concerned about the overall level of impact on seabird populations; especially as some of the species most affected are already experiencing significant population declines. The Neart Na Gaoithe development directly, and in combination with Inch Cape and Seagreen, is likely to have a significant effect on the integrity of a number of internationally important Special Protection Areas in the Firth of Forth.

We would like to stress again the importance of having a robust Environmental Management Plan in place which ensures that the monitoring of these impacts is continually assessed during construction and operation and that enables mitigation (including shut-down) to be taken as appropriate.

Wildlife tourism is well established in this part of Scotland and brings with it important socio-economic benefits and opportunities to provide information to the public on offshore windfarm developments. The Scottish Seabird Centre, which attracts 270,000 visitors a year, remain willing to engage with any organisation to help present impartial information that helps people to take an informed view about these offshore wind developments.
