1 PUBLIC NOTICES

1. This appendix includes the statutory Pre-Application Consultation (PAC) public notices prepared for the MachairWind Offshore Windfarm development, in accordance with the Marine (Scotland) Act 2010 and Section 7 of the Marine Licensing (Pre-Application Consultation) (Scotland) Regulations 2013. The notices outline the scope of the proposed offshore works, the consultation arrangements, and the opportunities provided for stakeholders and the public to engage with the evolving proposals. Their inclusion demonstrates compliance with statutory requirements and provides a transparent record of consultation activity undertaken prior to submission of consent applications.
2. In accordance with Section 7 of the 2013 Regulations, notice of the PAC event was published in a newspaper circulating in the locality where the proposed development is situated. For this purpose, the Oban Times was selected due to its established readership across Argyll, the Inner and Outer Hebrides, and the west coast of Scotland, aligning with the geographic areas most directly affected by the Project. The title's strong regional circulation and relevance ensure that communities with the greatest potential interest were appropriately informed of the consultation opportunity.
3. The appendix also demonstrates compliance with the regulatory requirements concerning the timing of PAC activity. Specifically, a pre-application consultation event must be held no earlier than six weeks after the later of:
 - (a) the date on which notification of the event is published in accordance with Section 7(1)(b); and
 - (b) the date on which notification of intent to submit a marine licence application is provided in accordance with Regulation 6(2).
4. The notices provided within this appendix were issued for the first and second rounds of Statutory Consultation on 24 April 2025 and 04 September 2025 respectively.



1.1 STATUTORY CONSULTATION ROUND ONE
