- 1. H beam sections will be secured to the quay wall. These will not be in contact with the seabed.
- 2. Pontoon sections will be connected together on the quayside and lifted into the water with a shore-based crane.
- 2. The complete pontoons will be maneuvered in the harbour to installation position.
- 3. The pontoon sections will be connected to the pre-installed runners on the pier wall H beams.
- 4. The ramps will be lifted into position with a shore-based crane and secured.
- 5. Utility services will be connected and commissioned.





(k) Potential impacts the works may have (including details of areas of concern e.g designated conservation and shellfish harvesting areas) and proposed mitigation in response to potential impacts (continue on separate sheet if necessary):

The pontoons will be located within Buckie Harbour, which is considered to be a low sensitivity environmental receptor due to its current use as a commercial port. The location of the pontoons within the harbour would be adjacent to an existing pier between two harbour basins currently used as vessel berths and therefore the installation of pontoons (as a floating structure attached to the harbour wall) would only be a minor change from its current use.

Buckie Harbour is not located within any protected sites or fishing areas. The harbour is adjacent to the Moray Firth SPA which is designated for supporting a non-breeding population of European importance of Annex 1 bird species, and for regularly supporting populations of European importance of migratory bird species. It is not considered that there is any potential for the proposed works to have any adverse effect on the qualifying features of the SPA, due to their nature and distance from the site. Therefore no mitigation is proposed.

The harbour is located approximately 1km (at its closest point) from the Southern Trench MPA which is designated for minke whale, benthic features and quaternary geology and geomorphology. It is not considered that there is any potential for the proposed works to have any adverse effect on the qualifying features of the MPA, due to their nature and distance from the site. Therefore no mitigation is proposed.

GEN1: The NMP sets an objective to promote the sustainable development of offshore wind energy in the most suitable locations. In doing so, it sets a presumption in favour of sustainable development and use of the marine environment when consistent with the policies and objectives of the NMP. The pontoon will be a component part of the operations and maintenance service base for the the Moray West Offshore Windfarm and therefore contributes to the development of offshore wind energy.

GEN2: The pontoon will be part of the operations and maintenance service base for the the Moray West Offshore Windfarm, and will therefore support a long term economic benefit to the local community and to the harbour authority. The development of the operations and maintenance base is also in line with the Buckie Harbour masterplan, as servicing offshore wind is one of the key elements of the masterplan.

GEN7: The pontoon situated within the harbour will have no significant adverse seascape, landscape and visual impact as a pontoon is a common component part of a harbour. The pier proposed to be used as the location for the pontoons is currently being used for vessel berthing and therefore the installation of the pontoon, whilst allowing safer access to vessels berthed alongside, will not fundamentally change the existing use of the location. The harbour is not located in, or near to, any National Scenic Area.

GEN9: As described above, the harbour is not located within any designated protected site, and it is not considered that there is any potential for the proposed works to have any adverse effect on the qualifying features of nearby designated sites.

GEN15: The pontoon will be part of the operations and maintenance service base for the the Moray West Offshore Windfarm, the development of which is in line with the Buckie Harbour masterplan, as servicing offshore wind is one of the key elements of the plan
