Coordinates taken from recent admiralty charts will be on a WGS84 compatible datum. Ordnance survey maps do not use WGS84.

The decimal point specifies that decimals of minutes are used and the datum is stated explicitly. If seconds are used then the format should be as in the example: 55°55'44''N 2°22'11''W (WGS84).

The premise of the development is to support the management of fish health and welfare by primarily modernising the equipment design and moving to fewer larger pens.

Consideration has been given to Scotland's National Marine Plan in reference to this application.

The plan outlines 7 objectives and 14 policies relating to aquaculture, all of which have been given consideration as part of this process. Details of which are as follows:

• 1 to 8 – The location of the site in this application has been considered and is felt to be appropriate. All necessary modeling has been carried out and the site has been found to be within all relevant limits.

 $\cdot$  5 – A Landscape assessment has been carried out bas part of the planning application process.

• 9 - Emergency response plans are in place for the site.

• 10 - Consultation and community engagement has been carried out as part of all significant applications, and formal consultation processes exist as part of the planning process.

• 11 - Equipment attestation for all installations are in place. There is a continued focus on reducing greenhouse gas emissions at all of our operations.

- 12 Biological controls for sea lice (cleaner fish are utilised at all Mowi sites)
- 13 Marine Harvest farm two species of cleaner fish and support multi-trophic farming as well as possible shellfish collaborations.

• 14 - Community benefits by maintaining the existing jobs at the farm and part of the wider community support program.
