Explanatory Notes

- (f) Describe the location of the proposed works. Include a list of the latitude and longitude co-ordinates (WGS84) of the boundary points of the moorings area and for each of the component parts of the marine farm, including sub-surface equipment. WGS84 is the World Geodetic System 1984 and the reference co-ordinate system used for marine licence applications. Co-ordinates taken from GPS equipment should be set to WGS84. Coordinates taken from recent admiralty charts will be on a WGS84 compatible datum. Ordnance survey maps do not use WGS84.

Example: For positions read from charts the format should be as in the example: 55°55.555'N 002°22.222'W (WGS84). The decimal point specifies that decimals of minutes are used and the datum is stated explicitly. If seconds are used then the format should be as in the example: 55°55'44"N 2°22'11"W (WGS84).

It is important that the correct positions, in the correct format, are included with this application, as any errors will result in the application being refused or delayed.

- the full extent of the works in relation to the surrounding area;
- latitude and longitude co-ordinates defining the location of the works;

Drawings and plans will be consulted upon. If they are subject to copyright, **it is the responsibility of the applicant to obtain necessary approvals to reproduce the documents and to submit suitably annotated copies with the application.**

- (g) Indicate if the marine farm is located within the jurisdiction of a statutory harbour authority and provide details of the statutory harbour authority where relevant.
- (h) Provide assessment of the potential impacts the works may have on navigation, including interference with other uses of the sea.

Where there are potential impacts from the works, please provide details of proposed mitigation in response to potential impacts.

6. Planning Permission

No adverse impacts on navigation are anticipated. The modified pen group proposed is in the vicinity of existing infrastructure, which it will replace, and as a result of the modification other sites in the bay will be inactivated, reducing the overall amount of farm equipment deployed. Discussing with local stakeholders (local inshore fisherman and resident leisure users of the bay) this consolidation of farming infrastructure is viewed positively. The surface equipment will continue to be marked (yellow X pole and flashing yellow light) as specified by the Northern Lighthouse Board. All equipment - pens, moorings and nets - will be subject to routine inspection and maintenance to ensure integrity and avoid potential risk to other marine users.

The project is in alignment with policy GEN 1, supporting the ongoing operation of marine farms in Badcall Bay which are operating with good practice & performance compatible with the NMP's Aquaculture policies (in particular AQ 1, 3, 12 & 14). Supporting the ongoing farm operations also aligns with policies GEN 2 & 3, ensuring continued socio-economic benefit in the local area in terms of employment, training opportunities, local community engagement and supply-chain use. Policy GEN 4 is also met, with the proposal being compatible with the ongoing activities of other marine users in Badcall Bay by achieving consolidation and modernisation of aquaculture infrastructure. There are no historic environment (GEN 6) or natural heritage interests (GEN 9) affected by the proposal, and being an area of well-established aquaculture activity no negative impact on landscape, seascape or local amenity are identified (GEN 7 & AQ 5). Finally, in alignment with policy AQ 11, the proposed equipment is fit for purpose and will be routinely maintained by the operator to ensure it stays as such.
