Include a list of the latitude and longitude co-ordinates (WGS84) of the boundary points of the moorings area and for each of the component parts of the marine farm, including sub-surface equipment. WGS84 is the World Geodetic System 1984 and the reference co-ordinate system used for marine licence applications. Co-ordinates taken from GPS equipment should be set to WGS84. Coordinates taken from recent admiralty charts will be on a WGS84 compatible datum. Ordnance survey maps do not use WGS84.

**Example:** For positions read from charts the format should be as in the example: 55°55.555'N 002°22.222'W (WGS84). The decimal point specifies that decimals of minutes are used and the datum is stated explicitly. If seconds are used then the format should be as in the example: 55°55'44"N 2°22'11"W (WGS84).

**It is important that the correct positions, in the correct format, are included with this application, as any errors will result in the application being refused or delayed.**

- (g) Indicate if the marine farm is located within the jurisdiction of a statutory harbour authority and provide details of the statutory harbour authority where relevant.
- (h) Provide assessment of the potential impacts the works may have on navigation, including interference with other uses of the sea.

Where there are potential impacts from the works, please provide details of proposed mitigation in response to potential impacts.

## 6. Planning Permission



No adverse impacts on navigation are anticipated, as the application relates to an existing farm. This renewal/update reflects a change in practice and updating of equipment whereby temporary or 'transport pens' are no longer used for grading or moving fish, and as such is a reduction in the number of pen units on site. The surface equipment will continue to be marked (yellow X pole and flashing yellow light) as specified by the Northern Lighthouse Board. All equipment - pens, moorings and nets - will be subject to routine inspection and maintenance to ensure integrity and avoid potential risk to other marine users.

The application is in alignment with policy GEN 1, supporting the ongoing operation of marine farms in Loch a Chairn Bhain which are operating with good practice & performance compatible with the NMP's Aquaculture policies (in particular AQ 1, 3, 12 & 14). Supporting the ongoing farm operations also aligns with policies GEN 2 & 3, ensuring continued socio-economic benefit in the local area in terms of employment, training opportunities, local community engagement and supply-chain use. There are no historic environment (GEN 6) or natural heritage interests (GEN 9) affected by the proposal, and being an existing site within an area of well-established aquaculture activity no negative impact on landscape, seascape or local amenity are identified (GEN 7 & AQ 5). Finally, in alignment with policy AQ 11, the proposed equipment is fit for purpose and will be routinely maintained by the operator to ensure it stays as such.
