At present aquaculture is dominated by Salmon farming and by large multinational companies pursuing salmon production. The Marine Plan highlights the need for diversity within aquaculture and looks, in some part, to shellfish farming for this.

The plan specifies a objective to increase shellfish production to 13,000T per annum, this development will make a small contribution towards this target.

Oyster farming is a very small sector in Scotland, to gain more traction and develop the market, supply chains, etc it needs to grow to the point where it is more visible to suppliers and to markets. This medium scaled oyster farm will demonstrate that even in the most remote and "hostile" environments, it is possible to successfully develop shellfish aquaculture businesses and that these will have benefits to the local economy. this in turn will engender confidence and lead to further investment and growth in the industry.

The development will underpin 4FTE, 1 PTE posts in a remote island community where population decline and unemployment are both significant issues.

Oysters are filter feeders and so in growing them there is no need to add feed or chemicals to the environment. Indeed it can be argued that the feeding action of oysters reduce the impacts of man made inputs to the environment by filtering them from the water column. The oysters are held at low stocking densities and as a result the diffuse nature of their faecal production is easily dispersed by wave energy and the flow of currents through the site. SEPA see no issue with pollution from oyster farms, even when production is on a large scale.

the farm will not impact other fisheries or aquacultural operations. Movement of the oysters to markets will however help to sustain and support local shellfish transport businesses.

On the whole the proposed development meets many of the objectives of the Marine Plan as is clearly demonstrated above.
