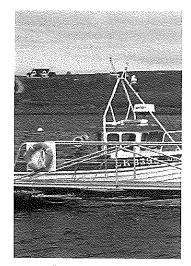

> Aithsvoe Pier Trust, Cunningsburgh, Shetland. Marine Licence Application

Please find enclosed the Trust's application for a licence to site two berthing pontoons at Aiths Voe Pier, together with plans and the application fee.

I appreciate that your organisation may not have much background information on our organisation, because the last consents granted to it for marine works were early in 2010.

The Trust was established in 1974, to regulate use of moorings in Aiths Voe and use of a stone pier there. Through the 1980s the surrounding land was acquired, the pier rebuilt and a breakwater constructed, all for recreational use by local boat-owner, along with a car parking area and a storage building with public toilets. The pier and slipway were again rebuilt around 2000, and berthing pontoons sited in 1998 and 2010. Today the facilities are still principally used for leisure activities, although some boat-owners are licensed for commercial activites, mainly creeling and lining for mackerel on a seasonal basis. The pier is occasionally used as a refuge in adverse weather to berth the commercial ferry run in summer between Sandsayre and the island of Mousa, a couple of miles from Aiths Voe. Over the year boats have become larger, giving rise to the Trustees' desire to provide more berthing – not mooring – space for pier users. The project's pontoons and moorings are second-hand ex-salmon farm, and all the necessary labour will be undertaken by the trustees themselves.

- (f) Provide the proposed start date for installation of the pontoon(s). The start date will not be backdated, since to commence a project for which a licence has not been obtained will constitute an offence, which may result in appropriate legal action. A licence is normally valid for 6 years. Target duration for determination of a marine licence application is 14 weeks.
- (g) Provide the cost of the works seawards of the tidal limit of MHWS. This estimate should only cover







work taking place below the tidal level of MHWS and must take into consideration the cost of materials, labour fees etc.

(h) Describe the location of the proposed works. Include a list of the latitude and longitude co-ordinates (WGS84) for the boundary points of the pontoon(s) including all moorings associated (if applicable). WGS84 is the World Geodetic System 1984 and the reference co-ordinate system used for marine licence applications. Co-ordinates taken from GPS equipment should be set to WGS84. Coordinates taken from recent admiralty charts will be on a WGS84 compatible datum. Ordnance survey maps do not use WGS84.

Example: For positions read from charts the format should be as in the example: 55°55.555'N 002°22.222'W (WGS84). The decimal point specifies that decimals of minutes are used and the datum is stated explicitly. If seconds are used then the format should be as in the example: 55°55'44"N 2°22'11"W (WGS84).

It is important that the correct positions, in the correct format, are included with this application, as any errors will result in the application being refused or delayed.

- o latitude and longitude co-ordinates defining the location of the works;

- any adjacent SAC, SPA, SSSI, MPA, Ramsar or similar conservation area boundary.

Drawings and plans will be consulted upon. If they are subject to copyright, it is the responsibility of the applicant to obtain necessary approvals to reproduce the documents and to submit suitably annotated copies with the application.

- (i) Indicate if the pontoon is located within the jurisdiction of a statutory harbour authority and provide details of the statutory harbour authority where relevant.
- (j) Provide a full method statement, including plan of how, when and where pontoon section(s) are proposed to be deposited and removed.
- (k) Provide assessment of the potential impacts the works may have, including interference with other uses of the sea. Please include details of areas of concern e.g designated conservation areas, such as a SAC, SPA, SSSI, MPA or Ramsar site and shellfish harvesting areas.
