If a project will not be completed before a marine licence lapses, it will be necessary for licence holders to re-apply for a further licence to continue any ongoing work at least 14 weeks prior to the expiry date of the licence. Target duration for determination of a marine licence application is 14 weeks.
- (d) Provide the proposed completion date of the project.
- (e) Provide the cost of the works seawards of the tidal limit of MHWS. This estimate should only cover



work taking place below the tidal level of MHWS and must take into consideration the cost of materials, labour fees etc.

(f) Describe the location of the proposed works. Include a list of the latitude and longitude co-ordinates (WGS84) of the boundary points of the proposed project. WGS84 is the World Geodetic System 1984 and the reference co-ordinate system used for marine licence applications. Co-ordinates taken from GPS equipment should be set to WGS84. Coordinates taken from recent admiralty charts will be on a WGS84 compatible datum. Ordnance survey maps do not use WGS84. In a few cases, (e.g. laying of long pipelines) it may only be practicable to supply co-ordinates for the start and end points.

Drawings and plans will be consulted upon. If they are subject to copyright, <u>it is the responsibility of the applicant to obtain necessary approvals to reproduce the documents and to submit suitably annotated copies with the application.</u>

Sewer outfalls, discharge pipes for industrial waste etc. The size and description of the pipe must be shown on the longitudinal sections and also details of its supports, foundations, methods of jointing and details of any tidal flaps.

Bridges over tidal waters: An elevation with longitudinal and cross-sections of the bridge to a suitable scale must show the dimensions of the spans and width of piers, etc. above and below MHWS and the maximum and minimum heights of the undersides of the superstructures above MHWS. The headroom above MHWS and the width of span of the nearest bridges, if any, above and below the site must be stated.

Tunnels under tidal waters: The longitudinal section of the tunnel must show the distances between the bed of the river or estuary and the top of the tunnels. Cross-sections must show the internal and external dimensions of the tunnel and particulars of construction. When a proposed future dredging level is known this must also be shown on all sections.

Overhead cables: Catenary must be supplied in addition to the site plan showing the minimum clearance of the cable at MHWS and the electrical clearance allowed.

Activity 1: Repair of sections of the existing sea wall. A survey has identified areas of deterioration (Figure: 70032892_602).

Activity 2: Connection of new drainage system to existing outfall (Figures: 70032892_603a & 603b), Proposed drainage construction is illustrated on Figure: 70032892-604).

Activity 3: Installation of a section (circa 173m) of new sheet pile wall on the seaward side of the existing sea wall (Figure: 70032892_601), which will facilitate remediation of material behind the wall and form a new section of river wall on completion of the remediation Works. The wall will be constructed as close to the existing wall as reasonably possible. The fenders and ironworks will be removed prior to the piling. The void behind the new sheet pile wall will be filled with suitable material and the ends tied into the existing river wall structure. Remediation will then progress by dismantling of the existing river wall structure to remove the relieving platform to 3.7m below ground level and to depths of 6.5m below ground level to remove impacted ground. Material will then be backfilled up to existing ground levels. A pedestrian guard rail shall be provided upon completion of backfilling behind the wall.

The foregoing are outline design drawings which the remediation contractor (or specialist sub contractor) will employ to finalise design and produce suitably developed method statements.

(i) Potential impacts the works may have (including details of areas of concern e.g designated conservation and shellfish harvesting areas) and proposed mitigation in response to potential impacts (continue on separate sheet if necessary):

During piling of replacement sheet pile wall, there is a potential for short term release of hydrocarbon sheens. Use of booms to limit the extent and contain any sheening. Other activities considered to provide betterment rather than impact.

The river wall piling works are to be undertaken during the summer months to avoid impacts to wintering redshanks (as discussed and agreed with SNH), with visual screen installed prior to the planned works to mitigate potential visual disturbance.

A watching brief will be undertaken in relation to noise impacts to marine mammals, if such animals are observed in proximity to the site piling works in the River Clyde are to be suspended until they have moved away.
