Regarding the General Policy of the plan, the proposed works are in the interest of local development by providing additional berth space in the harbour to meet local demand. This will support the local fishing trade and commercial leisure craft. There will also be a berth reserved for visiting craft.
Regarding the policy on Sustainable Development, the project promotes growth on industry in and around the harbour.
There is also a safety aspect to the works. If there aren't enough berth space at along the quay wall, the boats will double and triple berth along side one another to access the wall ladders. This then means that the personnel jump between boats to move between their boat and the quayside.
