SEAGREEN BRAVO OFFSHORE WIND FARM, FIRTH OF FORTH

AUTHORISATION FOR THE ASSIGNATION OF A CONSENT GRANTED IN ACCORDANCE WITH SECTION 36 OF THE ELECTRICITY ACT 1989 AND TRANSFER OF MARINE LICENCE IN ACCORDANCE WITH SECTION 30(8) OF THE MARINE (SCOTLAND) ACT 2010 AND SECTION 72(7) OF THE MARINE AND COASTAL ACCESS ACT 2009

We thank you for your letter and enclosures dated 09 October 2019 requesting the assignation of the Seagreen Bravo Offshore Wind Farm Section 36 Consent and transfer of marine licence 04677/18/0 from Seagreen Bravo Wind Energy Limited to Seagreen Alpha Wind Energy Limited.

As acting agent on behalf of Seagreen Bravo Wind Energy Limited, please find enclosed letter addressed to Seagreen Bravo Wind Energy Limited (Assignor). A letter in identical terms has also been sent to Seagreen Alpha Wind Energy Limited (Assignee) at their registered address.

The Scottish Ministers hereby authorise the assignation of the Seagreen Bravo Offshore Wind Farm Section 36 Consent dated 10 October 2014 by the Assignor to the Assignee, in accordance with condition 4, Annex 2 to the Section 36 Consent, subject to the following conditions set out in the enclosed letter.

The assignation must be given no later than 4 weeks of the date of this letter and must be intimated by the Assignee to the Scottish Ministers by sending to them a certified copy of the assignation no later than 2 weeks of the date of the giving of the assignation.

Regarding the transfer of the marine licence, the transfer of the marine licence will be treated as a variation under Section 30 of the Marine (Scotland) Act 2010 and Section 72 of the Marine and Coastal Access Act 2009.

Due consideration has been given to this and we do not believe that anyone will be adversely affected by the variation and therefore consultation will not be required. We will make the necessary changes and issue the licence along with the variation fee of £60.

Once this is complete, we will then inform all of the consultees from the original application that the Section 36 Consent assignation has taken place and then re-issue the marine licence in name of Seagreen Alpha Wind Energy Limited.

SEAGREEN BRAVO OFFSHORE WIND FARM, FIRTH OF FORTH

AUTHORISATION FOR THE ASSIGNATION OF A CONSENT GRANTED IN ACCORDANCE WITH SECTION 36 OF THE ELECTRICITY ACT 1989

The Scottish Ministers hereby authorise the assignation of the Seagreen Bravo Offshore Wind Farm Section 36 Consent dated 10 October 2014 by the Assignor to the Assignee, in accordance with condition 4, Annex 2 to the Consent, subject to the following conditions.

I am sending a letter in identical terms to the Assignee also.

Conditions

1. The assignation must be given no later than 4 weeks of the date of this letter and must be intimated by the Assignee to the Scottish Ministers by sending to them a certified copy of the assignation no later than 2 weeks of the date of the giving of the assignation.
2. If the assignation, and intimation, are not given within the time periods specified in condition 1 then the Scottish Ministers' authorisation for the assignation is no longer valid in which case a new authorisation would require to be given by the Scottish Ministers under condition 4, Annex 2 to the Consent before any assignation may be given.
3. The Assignee must give written notice of the assignation to the relevant Planning Authority within 1 week of the date on which the assignation is given.
4. For the avoidance of doubt, the Assignee is required to comply with all the conditions of the Consent (except in so far as any condition has, prior to the date of the giving of the assignation, been fully implemented and does not have continuing effect). This

requirement also means that the Assignee, in terms of condition 2, Annex 2 to the Consent, is not permitted to further assign the Consent without the prior written authorisation of the Scottish Ministers.

5. The Assignee must confirm to the Scottish Ministers that they will, following the assignation, honour, in full, any community benefit package which has, prior to the date of the giving of the assignation, been agreed between the Assignor and any relevant authorities.
6. The Assignee must confirm to the Scottish Ministers that the relevant Planning Authority has been notified of the transfer of assignation in terms of condition 3 above.

Definitions

In this letter:

“the Assignee” means Seagreen Alpha Wind Energy Limited, a company having their registered office at No.1 Forbury Place, 43 Forbury Road, Reading, United Kingdom RG1 3JH. Company Registration No 07185533

“the Assignor” means Seagreen Bravo Offshore Wind Energy Limited, a company having their registered office at No.1 Forbury Place, 43 Forbury Road, Reading, United Kingdom RG1 3JH. Company Registration No 07185543.

“the Consent” means the Section 36 Consent (including all the conditions of the Consent) granted to Seagreen Bravo Wind Energy Limited, by the Scottish Ministers for the construction and operation of the Seagreen Bravo Offshore Wind Farm located within the outer Firth of Forth, approximately 38km from the Angus Coastline, off the East of Scotland and enclosed with the decision letter of 10 October 2014.

“the relevant Planning Authority” means Angus Council, Dundee City Council, Fife Council, East Lothian Council and Scottish Borders Council.
