The electricity networks of Skye and South Uist are currently connected via a single 33 kV subsea cable running from Skye - South Uist, which was identified as requiring replacement. To facilitate this and improve network flexibility, the overall project is planned as two cable systems which are being progressed through two separate licence applications. Scottish Hydro Electric Power Distribution plc (SHEPD) is proposing to install an additional 33kV submarine electricity cable interlinking Loch Pooltiel, Skye and Ardmore, Skye (the subject of this application) as well as a cable between Loch Pooltiel and South Uist (being applied for separately). SHEPD is seeking a Basking Shark licence to enable them (and their contractors) to use vessels and project equipment to install this additional cable.

- (e) Briefly state how you will minimise the impact of your proposed work on Basking shark.

Information on mitigation methods is presented in Section 4 and Section 7 of the MEA Report (P2816_R6690). Mitigation specifically applying to the basking shark is outlined below:

- Slow moving vessels - the installation vessel will be moving at a maximum speed of 4 knots to allow any basking sharks time to move away from the vessel should they be disturbed by the vessel presence or noise. Should a Basking Shark be found to be in the direct way of the route, the vessel will slow down further or, if possible, alter course to avoid collision.

- Toolbox talks - Crew will be made aware of all protected species within the marine environment through guidance such as the Marine Conservation Society (MCS) Basking Shark Code of Conduct and good practice measures for boat control near basking sharks.

The proposed Application Corridor is located within three protected sites, the Inner Hebrides and the Minches Special Area of Conservation (SAC), the Sea of Hebrides Nature Conservation Marine Protected Area (NCMPA) and Ascrib, Isay and Dunvegan SAC. 7. Satisfactory alternatives

SHEPD has considered various options in relation to the installation of the Ardmore - Loch Pooltiel cable and have decided to proceed with a subsea cable installation of a 33kV subsea cable interlinking Skye (Loch Pooltiel) and Ardmore (~20km), utilising new landfalls at Ardmore South and Loch Pooltiel (Meanish Pier), Skye. In comparison to other feasible landfall sites these options had minimal disturbance and will allow for greater flexibility in the power distribution network between Ardmore and Loch Pooltiel, while maintaining the favourable conservation status of basking shark within the works or adjacent area.

The wider replacement of the Skye - South Uist cable is required to meet SHEPD's commitments to provide a reliable supply of electricity between the two islands. The following options were also explored: - Do nothing - this option was rejected owing for the need for the connection between Skye and South Uist - Use an alternative landfall - alternative landfalls at Loch Pooltiel East and Milovaig Beach on Skye, and Ardmore West and Ardmore East were identified during route engineering, however none of the options were progressed further due to various limitations as discussed in Section 1.3 of the MEA (P2816_R6690).

During the development of the Ardmore - Loch Pooltiel cable project, SHEPD has considered all relevant policies within the National Marine Plan (NMP). The MEA document (P2816_R6690) has considered the specific policies relating to submarine cables (Cables 1, 2, 3 and 4), sea fisheries (Fisheries 1 and 2) and shipping, ports, harbours and ferries (Transport 1 and 6) (Section 2.8). Other relevant policies in the NMP include, but are not limited to: GEN 1, GEN 2, GEN 4, GEN 9, GEN 12, GEN 13, GEN 15, GEN 16 and GEN 18.

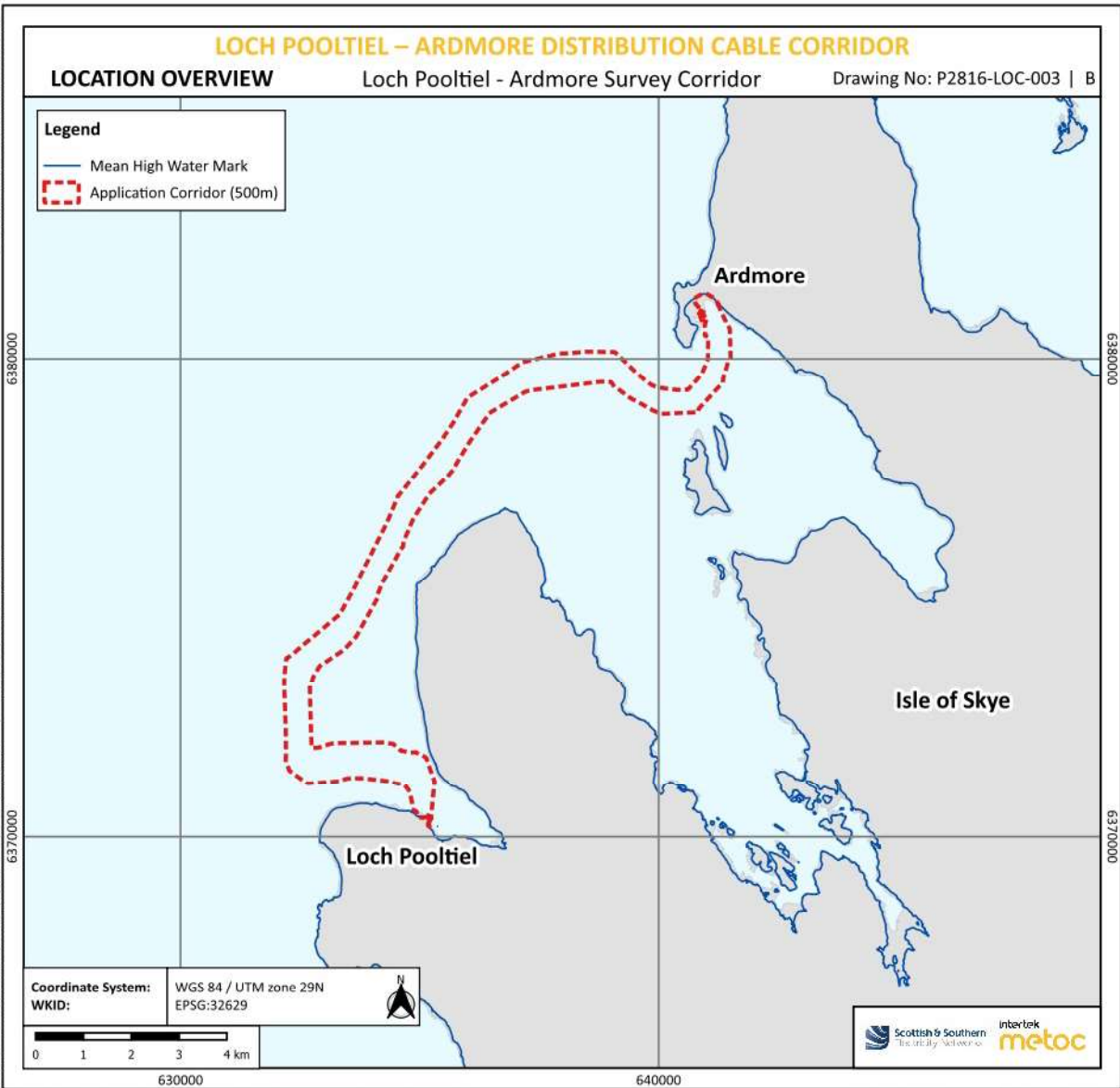
