EIA Screening Opinion for Variation to Section 36 Consent and Generating Station Marine Licence for the Moray West Offshore Windfarm at Moray West Offshore Wind Farm, Outer Moray Firth

I refer to your request for a Screening opinion for the above proposal received on 11 September 2020. Having reviewed the detail of the submission, I can confirm that in terms of Aberdeenshire Council's interests, the proposed amendments to the development are not considered to be so significant as to represent EIA Development.

The proposed amendments concern an increase in proposed wind turbine blade width from 6m up to 6.6m in one of the potential three development scenarios approved. Aberdeenshire Council's primary interests with regard to this development relate to the Sea and Landscape Visual Impact of the scheme. In the event of this increased blade width being utilised, it is not considered that this would lead to any significantly differential impacts compared to the approved development. The 0.6m or 10% change in blade width is highly unlikely to be noticeable from any viewpoints within Aberdeenshire.



The details concerning the unlikelihood of any associated ornithology impacts as a result of this change are also noted. We would suggest that SNH and RSPB are consulted on this aspect. This is not a matter which Aberdeenshire Council would comment on.

The amendment to remove the nominal 850MW capacity and thus allow for a higher output raises no concerns from an Aberdeenshire Council perspective.

Overall therefore, while it is noted that there is a proposed change to the physical parameters of the scheme, this does not result in any significantly differential impacts to the issues of most relevance to Aberdeenshire Council. As such, the proposed amendments in themselves and with sole regard to our interests, would not constitute EIA Development.

Good afternoon and apologies again for the delay in responding. Having reviewed the screening report and considered the proposals against the screening criteria set out in the relevant electricity and marine EIA legislation we would comment as follows.

It is noted that this proposed offshore windfarm was at its closest 32km from the coastline of the Moray Council authority area, and in referring original Section 36 submissions and visualisations the difference of increasing the 6m blade width for the original EIA submissions to 6.6m wide will, in terms of visual effects, be so minimal as not to constitute EIA development in itself. There are no other implications of the blade width increase that we can foresee from our perspective that would require EIA.

The maximum generating capacity of around 850 MW from Moray Councils perspective is a matter separately addressed onshore under Moray Planning application reference 18/01046/EIA approved in Dec 2018 which dealt in principle with the National level development for the onshore transmission works by Moray Offshore Windfarm (West) Limited. The offshore implications therefore on the Section 36 consent from removing the upper limit of generating capacity would similarly have no implication for Moray Council as to warrant EIA itself. Any infrastructural or engineering changes resulting from the removal of the generating capacity limit (around 850mW) would have no EIA implications for Moray Council.

Dear Debbie,

Thank you for the consultation regarding the screening opinion for the proposed variation to the Moray West offshore wind farm Section 36 consent. We have reviewed the screening report and consider that proposed variation is not an EIA project in terms of the Marine Works Regulations and/or an EIA development in terms of the Electricity Works Regulations.

The additional collision risk modelling carried out for the 72 turbine scenario with an increase in blade width from 6m to 6.6m shows that the predicted collisions are slightly lower than those predicted in the modelling carried out for the consented application. Therefore, we agree that the conclusions reached by Moray West and Scottish Ministers remain valid.

We also agree that the removal of the reference to Moray West having a maximum generating capacity of 850MW will not affect any of the conclusions presented by Moray West.
