Thank you for consulting NatureScot on the revised Construction Programme (CoP) and Construction Method Statement (CMS) for Neart na Gaoithe Offshore Wind Limited (NnGOWL). We have reviewed the revised document (NNG-NNG-ECF-PLN-0002 Rev 7) and note the change to the timings in Table 4-1, including changes to:

- Installation and burial of the inter-array cables from July 2023 October 2023, amended to April 2023 – January 2024;
- OSP North topside installation from May 2023, to December 2022; and
- Interconnector cable installation from July 2023 to April 2023.

We note that these changes in timings are reflected in the subsequent text throughout Section 4. We also note the addition of text around WTGs potentially undergoing a period of standstill in Section 6.4 and minor changes to cable lengths in Table 6-2.

We have no substantive comments to make.
