### **Seagreen Alpha Wind Energy Ltd and Seagreen Bravo Wind Energy Ltd Discharge of Conditions – Project Environment Management Plan (PEMP)**

Thank you for your consultation on the 31st July 2019 on the Project Environment Management Plan (PEMP) submitted by Seagreen Alpha Wind Energy Limited and Seagreen Bravo Wind Energy Limited (Seagreen) for the purpose of discharging consent conditions for the 2014 consented project. The PEMP (document reference LF000009-CST-OF-PRG-0003) applies to the Seagreen Alpha and Seagreen Bravo offshore windfarms and the Offshore Transmission Assets (OTA) with a focus on monitoring activities during the pre-construction phase.

We have reviewed the PEMP and are satisfied that it sets out the process to be followed for the environmental monitoring, acknowledging that approval has already been reached with respect to the pre-construction monitoring approach for:

- sandeels, marine fish and diadromous fish,
- benthic communities,
- scour and local sediment deposition,
- marine mammals.

The Ornithology Monitoring Strategy (OMS) was discussed at the FTRAG-O meeting on the 2nd July 2019, and in relation to the following aspects (outlined below), will be subject to further discussion and agreement on the pre-construction, construction and operational aspects of monitoring, prior to approval:

- survey buffers and the final survey extent,
- use of three planes for aerial surveys during winter months,
- colony-based monitoring at Fowlsheugh and St Abb's Head to Fast Castle SPAs,
- tagging studies.

Notwithstanding this, the OMS provided by Seagreen (document reference LF000009--CST-OF-REP-0016) is in our view appropriate and we will continue to participate and provide further advice via FTRAG-O to move this process forward.

- Ornithology Monitoring Strategy
- Preconstruction Marine Mammal Monitoring Plan
- Marine and Migratory Fish Monitoring Plan
- Benthic Monitoring Plan

The conditions state that the PEMP must be submitted to the Licensing Authority for their written approval, following consultation by the Licensing Authority with SNH, RSPB, WDC and ASFB and any such other advisors or organisations as may be required at the discretion of the Licensing Authority.

We would appreciate any comments you may have on the proposed PEMP, in order to determine whether it is fit for purpose for the Scottish Ministers approval. Please note that we do not seek comments on the Marine Licence, s.36 nor on the conditions, which will not be amended.
