Clean Energy From Ocean Waves (CEFOW) Project: EMEC Billia Croo Test Berth 5 – Marine Licence Application

Please find attached the Marine Licence application for the installation, operation and decommissioning of a three device array under the CEFOW project at Test Berth 5, at the Billia Croo wave test site, European Marine Energy Centre (EMEC). The European Commission Horizon 2020 project, CEFOW, intends to install, operate and decommission three of Wello's 'Penguin' wave energy converters (WECs) by the end of 2020.

EMEC is submitting the application on behalf of Fortum Energy Ltd UK (termed Fortum), the lead partner under the CEFOW project. As Wello Oy was the previous licence holder for the first WEC under the CEFOW project, statements regarding the transfer of obligations associated with the assets from both Wello and Fortum have been provided in connection with this licence application. It should be noted that the decommissioning financial securities placed with the UK Government's Department for Business, Energy and Industrial Strategy have been provided by Fortum. In addition, the proposed licence expiry date is 1st March 2021 with the purpose of providing flexibility within the licence and allowing for future delays within the project schedule.
