SEAGREEN BRAVO OFFSHORE WIND FARM – ASSIGNATION OF SECTION 36 CONSENT

We refer to:

1. The consent for the construction and operation of the Seagreen Bravo Offshore Wind Farm granted to Seagreen Bravo Wind Energy Limited (a company incorporated in England and Wales under the Companies Acts with registered number 07185543 whose registered office is at No.1 Forbury Place 43 Forbury Road, Reading, United Kingdom, RG1 3JH ("**SBWEL**")) by the Scottish Ministers under Section 36 of the Electricity Act 1989 on 10 October 2014, as varied by the Scottish Ministers by decision letter dated 28 August 2018 issued pursuant to an application under section 36C of the Electricity Act 1989 ("**Section 36 Consent**"); and
2. The Scottish Ministers' consent to the assignation of the Section 36 Consent by SBWEL to Seagreen Alpha Wind Energy Limited (a company incorporated in England and Wales under the Companies Acts with registered number 07185533 whose registered address is at No.1 Forbury Place 43 Forbury Road, Reading, United Kingdom, RG1 3JH ("**SAWEL**")) dated 29 October 2019 (the "**Scottish Ministers' 2019 Consent Letter**").

On behalf of our client, SAWEL, we hereby intimate to you that with effect from 22 November 2019, SBWEL has assigned the benefit and the burden of the Section 36 Consent to SAWEL by assignation dated 22 November 2019 (the "**Assignment**"). A certified copy of the Assignation is enclosed.

Pursuant to the terms of Condition 5 of the Scottish Ministers' 2019 Consent Letter and on behalf of our client, SAWEL, we confirm to the Scottish Ministers that SAWEL will honour, in full, any community benefit package which has, prior to the date of the assignation, been agreed between SBWEL and any relevant authorities.

Further to Condition 6 of the Scottish Ministers' 2019 Consent Letter and on behalf of our client, SAWEL, we also confirm to you that the relevant Planning Authorities, being Angus Council, Dundee City Council, Fife Council, East Lothian Council and Scottish Borders Council have been notified of this assignation by way of letters dated 27 November 2019.
