The purpose of deploying the Datafish is to measure the local tidal cycle and tidal flows at the MeyGen site in real time. Although we have an accurate model that provides tidal flow data we have found that local environmental pertubations can bring forward or retard the tidal cycle by up to 30 minutes .

Knowledge of this real time information is critical in planning the forth coming installation campaign scheduled for the next neap tide 05/11 to 11/11/2016.

(g) Method statement including schedule of work (continue on separate sheet if necessary):
Deployment Position - 491576 / 6502270, Water Depth - 34 Meters LAT. The mooring is to consist of a 5 tonne clump weight made from link chain and a dyneema mooring line with a Minimum Breaking Load of 15 tonne.
The vessel will transit to site. 30 minutes before the predicted slack water the site will be approached facing into the tide. Once conditions are permissible for the mooring to be lowered the clump weight will be released from deck and suspended over the bow ready for deployment. With the position confirmed the clump weight will be lowered to the seabed. Once it touches down the mooring line will stoppered off, and the remaining line released from the winch. This end should be attached to the upper mooring line (with swivel and 4.75T shackle). Ensure that the line does not run through one of the stands. DataFish® can then be attached to the crane using a looped 4m sling. Once the deck is clear DataFish® should be lifted from the deck and into the water over the bow of the vessel. Release the mooring line from the stopper and cast over board taking care that it is not sucked into the thrusters.

The works are located in the North Caithness Cliffs Special Protected Area (SPA).
