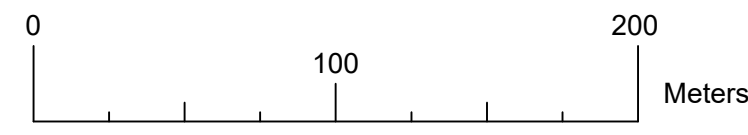


- NOTES**
