Geophysical survey work including Subsea Positioning Ultra-Short Baseline ("USBL"), Multibeam Echo Sounder and Side-Scan Sonar

#### LICENCE CONDITIONS

- 1. The Licensee must ensure that all licensed activities are carried out in strict accordance with the mitigation and working methods proposed in the application for this licence to disturb European protected species, together with supporting information and all licensed activities must be carried out within the timescale(s) given within the application and any subsequent written correspondence between Marine Scotland and the applicant, but subject to the following modifications or amendments made within this licence.
- 2. The Licensee must ensure that all licensed activities are carried out in strict accordance with the Operation & Maintenance Phase USBL EPS Risk Assessment (REPORT 1197777 1- A) dated 23 May 2019.
- 3. in the event of the Licensee becoming aware that any of the information on which the issue of this licence was based has changed, the Licensing Authority must be notified as soon as reasonably practicable.
- 4.The Licensee must ensure that, if any aspects of the proposed activities differ from the detail submitted in the Noise Registry Initial Registration Form, a new Initial Registration Form shall be completed and submitted to the Licensing Authority and the Joint Nature Conservation Committee ("JNCC") no later than one week prior to commencement of the licensed activities.

5. The Licensee must ensure that where survey equipment has the capability to undergo a soft start procedure, this is implemented on every occasion survey equipment is switched on.

- 6. The Licensee must ensure that the Joint Nature Conservation Committee ('JNCC") 2017 Guidelines for minimising the risk of injury and disturbance to marine mammals from seismic surveys is followed at all times in connection with the undertaking of such surveys as far as it is practical to do so. These are available from the JNCC website http://jncc.defra.gov.uk/pdf/jncc\_guidelines\_seismicsurvey\_apr2017.pdf.
- 7. Except where it is not relevant to the provisions of this licence, the Licensee must ensure that the Scottish Marine Wildlife Watching Code is adhered to at all times.
- 8. The Licensee must ensure that copies of the licence are available for inspection by any person authorised by the Scottish Ministers at the office of the Licensee and at all sites where licensed activities are taking place.
- 9. Any person authorised by the Scottish Ministers must be permitted to inspect the operations relating to the licence at any reasonable time. The Licensee must allow appropriate assistance to facilitate inspection.
- 10. The Licensee must, no later than one month after the expiry date of this licence, submit to Marine Scotland, Planning and Policy, Licensing Operations Team, a written report detailing all actions taken in accordance with the specified terms and conditions of the licence. This report must detail the procedures, visual observations and include the original Marine Mammal Recording Form(s). Any difficulties encountered, or recommendations should also be noted.
- 11. The licence holder must, no later than 12 weeks after completion of the noisy activity, complete a 'close-out' noise registry form. This is available from the JNCC website https://mnr.jncc.gov.uk/
- 12. When carrying out pre-work searches the Licensee must ensure that a mitigation zone with a minimum radius of 500 metres is employed by the Marine Mammal Observer or a suitably-briefed member of the crew. The Licensee should ensure that the geophysical survey works only commence after the suitably-briefed member of the crew is satisfied that no animals have been observed within said mitigation zone for a minimum period of 30 minutes.
