This licence is granted for permitting disturbance of the above named species as a result of the following activities:

Cable surveying, with the use of equipment including Sub-bottom profiling "SBP", Multibeam Echosounder, and Ultra-short Baseline system "USBL".

LICENCE CONDITIONS

- 1. The licensee must ensure that all works are carried out in strict accordance with the mitigation and working methods proposed in the application for this licence, together with supporting information and all works must be carried out within the timescale given within the application and any subsequent written correspondence between Marine Scotland Licensing Operations Team (MS-LOT) and the applicant, but subject to the following modifications or amendments made within this licence.
- 2. The licensee must ensure that all works are carried out in strict accordance with the EPS and Protected Sites and Species Risk Assessment West Highlands (version A02) submitted to the licensing authority on 30 August 2019.
- 3. In the event of the licensee becoming aware that any of the information on which the issue of this licence was based has changed, the licensing authority must be notified as soon as reasonably practicable.







4. The licensee must ensure that the Joint Nature Conservation Committee (JNCC) guidelines for minimising the risk of injury and disturbance to marine mammals from geophysical surveys dated August 2017 ("JNCC Guidance") is followed at all times in connection with the undertaking of such surveys as far as it is practical to do so. These are available from the JNCC website http://incc.defra.gov.uk/pdf/incc_quidelines_seismicsurvey_apr2017.pdf

- 5. The licensee must ensure that, if any aspects of the proposed activities differ from the detail submitted in the online Marine Noise Registry, a new Proposed Activity Form is completed and submitted no later than one week prior to commencement of the licensed activities.
- 6. The licensee must ensure that where survey equipment has the capability to undergo a soft start procedure, this is implemented on every occasion survey equipment is switched on.
- 7. Except where it is not relevant to the provisions of this licence, the licensee must ensure that the Scottish Marine Wildlife Watching Code is adhered to at all times.
- 8. The licensee must ensure that copies of the licence are available for inspection by any person authorised by the Scottish Ministers at the office of the licensee and at all sites where licensed activities are taking place.
- 9. Any person authorised by the Scottish Ministers must be permitted to inspect the operations relating to the licence at any reasonable time. The licensee must allow appropriate assistance to facilitate inspection.
- 10. The licensee must, no later than one month after the expiry date of this licence, submit to the Scottish Ministers, a written report detailing all actions taken in accordance with the specified terms and conditions of the licence. This report must detail the procedures, visual observations and include the original Marine Mammal Recording Form(s). Any difficulties encountered, or recommendations should also be noted.
- 11. The licence holder must, no later than 12 weeks after completion of the noisy activity, complete and submit a Close-out Report the online Marine Noise Registry.
- 12. The Licensee must ensure that all mitigation measures included in the EPS and Protected Sites and Species Risk Assessment West Highlands (version A02) for Ultra-short Baseline system are applied when using multibeam echosounder (MBES) equipment operating below 200kHz.
