

## THE CONSERVATION (NATURAL HABITATS, &C.) REGULATIONS 1994

### LICENCE TO DISTURB MARINE SPECIES

**Licence Number: EPS/BS-00009686**

This licence is granted under regulation 44(e) of the Conservation (Natural Habitats, &c.) Regulations 1994 by the Scottish Ministers who, after consultation with, and having been advised as to the circumstances in which they should grant such licences by NatureScot are satisfied as regards the purpose for which the licence is granted, namely, for preserving public health or public safety or other imperative reasons of overriding public interest including those of a social or economic nature and beneficial consequences of primary importance for the environment; and that (a) there is no other satisfactory alternative and (b) that the action authorised will not be detrimental to the maintenance of the population of the species concerned at a favourable conservation status in their natural range; and unless revoked by the Scottish Ministers is valid from **20 October, 2022** to **30 June, 2025** and authorises:

Or any person authorised in writing by him / her to disturb the European protected species of *harbour porpoise (Phocoena phocoena)*; *bottlenose dolphin (Tursiops truncatus)*; *minke whale (Balaenoptera acutorostrata)*; *Risso's dolphin (Grampus griseus)*; *white sided dolphin (Lagenorhynchus acutus)*; *short beaked common dolphin (Delphinus delphis)*; *killer whale (Orcinus orca)*; *humpback whale (Megaptera novaeangliae)* at Deep Water Port, Glumaig Bay, Stornoway, as detailed in the application for a licence to disturb European Protected Species and supporting documents but only subject to the under-noted conditions:

### **PURPOSE AND CIRCUMSTANCES IN WHICH ACTION IS REQUIRED**

This licence is granted for the purpose of permitting the disturbance of *harbour porpoise (Phocoena phocoena)*; *bottlenose dolphin (Tursiops truncatus)*; *minke whale (Balaenoptera acutorostrata)*; *Risso's dolphin (Grampus griseus)*; *white sided dolphin (Lagenorhynchus acutus)*; *short beaked common dolphin (Delphinus delphis)*; *killer whale (Orcinus orca)*; *humpback whale (Megaptera novaeangliae)* at Deep Water Port, Glumaig Bay, Stornoway, for preserving public health or public safety or other imperative reasons of overriding public interest including those of a social or economic nature and beneficial consequences of primary importance for the environment in connection with Construction and Capital dredging for deep water port improvements at the following location(s):

## LICENCE CONDITIONS

1. The Licensee must ensure that all licensed activities are carried out in strict accordance with the mitigation and working methods proposed in the application for this licence, together with supporting information and all licensed activities must be carried out within the timescale(s) given within the application and any subsequent written correspondence between Marine Scotland – Licensing Operations Team ("MS-LOT") and the applicant, but subject to the following modifications or amendments made within this licence.
2. The Licensee must ensure that all licensed activities are carried out in strict accordance with the Stornoway Deep Water Port-Marine Mammal and Basking Shark Risk Assessment.
3. In the event of the Licensee becoming aware that any of the information on which the issue of this licence was based has changed, the Licensing Authority must be notified as soon as reasonably practicable.
4. The Licensee must ensure that the JNCC 2010 Guidelines for minimising the risk of injury and disturbance to marine mammals from piling noise is followed at all times in connection with the undertaking of such piling activities as far as it is practical to do so. 5. The Licensee must ensure that, if any aspects of the proposed activities differ from the detail submitted in the Noise Registry - Initial Registration Form, a new Initial Registration Form must be completed and submitted to the Scottish Ministers and the JNCC no later than one week prior to commencement of the licensed activities.
6. The Licensee must ensure that soft start procedures are employed for piling operations where applicable.
7. The Licensee must ensure that a dedicated marine mammal observer carries out a 20 minute pre-survey watch of the area within 500m of the piling location for the presence of marine mammals, prior to the commencement of piling. If a marine mammal is observed within the 500m observation zone in the 20 minutes prior to the commencement of piling, the Licensee must ensure that piling is not commenced until 10 minutes after the last sighting of a mammal.
8. Except where it is not relevant to the provisions of this licence, the Licensee must ensure that the Scottish Marine Wildlife Watching Code is adhered to at all times.

9. The Licensee must ensure that copies of the licence are available for inspection by any person authorised by the Scottish Ministers at the office of the Licensee and at all sites where licensed activities are taking place.

10. Any person authorised by the Scottish Ministers must be permitted to inspect the operations relating to the licence at any reasonable time. The Licensee must allow appropriate assistance to facilitate inspection.

11. The Licensee must, no later than one month after the expiry date of this licence, submit to MS-LOT, a written report detailing all actions taken in accordance with the specified terms and conditions of the licence. This report must detail the procedures, visual observations and include the original Marine Mammal Recording Form(s). Any difficulties encountered, or recommendations should also be noted.

12. The Licensee must, no later than 12 weeks after completion of the noisy activity, complete a 'close-out' noise registry form. This is available from the JNCC website <https://mnr.jncc.gov.uk/>.
