Include a list of the latitude and longitude co-ordinates (WGS84) of the boundary points of the moorings area and for each of the component parts of the marine farm, including sub-surface equipment. WGS84 is the World Geodetic System 1984 and the reference co-ordinate system used for marine licence applications. Co-ordinates taken from GPS equipment should be set to WGS84. Coordinates taken from recent admiralty charts will be on a WGS84 compatible datum. Ordnance survey maps do not use WGS84.

**Example:** For positions read from charts the format should be as in the example: 55°55.555'N 002°22.222'W (WGS84). The decimal point specifies that decimals of minutes are used and the datum is stated explicitly. If seconds are used then the format should be as in the example: 55°55'44"N 2°22'11"W (WGS84).

- (h) Provide assessment of the potential impacts the works may have on navigation, including interference with other uses of the sea.

(h) Potential impacts the works may have on navigation and proposed mitigation in response to potential impacts (continue on separate sheet if necessary):

Ouseness is a long established site and passing vessels and any other marine based activities should also already take into consideration the established mooring containment area for the site. The MCA is established on the basis of both site safety and vessel safety for other marine users. The potential for significant effects on navigation, anchorage, and other non-recreational maritime users was however considered by consultees during the screening and scoping and planning process for the new barge.

The new barge is to be established within this existing MCA area without alteration to the sites planning boundary. The barge is therefore not anticipated to result in any additional, significant, cumulative or indirect impacts to navigation, anchorage, fisheries or other non-recreational marine users.

Mitigation measures include: appropriate navigational lighting/marks to minimise potential displacement and/or collision risk. In ensuring the appropriate strategies of site containment, navigational marking, and use of equipment suitable for the anticipated conditions from the outset of the development, the residual risk to navigation and anchorage is considered negligible and unlikely to result in any significant effects.

Ouseness is an existing site however the new barge was considered alongside aspects of Scotland's National Marine Plan. Details are as follows:

Policies 1-8: Site location was carefully chosen to minimise impacts relating to carrying capacity/location guidelines, visual amenity, disease management areas, wild fish and seal haul out areas. All required modelling and assessment has also been conducted and the site is considered to be within all required limits.

Policy 9: Emergency response plans are in place for the site.

Policy 10: Statutory and non-statutory consultation was conducted prior to the submission of formal applications.

Policy 11: Equipment attestations from manufacturers are available for all proposed equipment and detailed mooring modelling also conducted. The site will also be compliant with the Marine Scotland Technical Standards for Aquaculture.

Policy 12: Cooke Aquaculture Scotland owns and operates a dedicated hydrolicer vessel and has access to freshwater treatments for lice removal.

Policy 13: Cooke Aquaculture Scotland are actively researching the potential for integrated, multi-trophic aquaculture.

Policy 14: Community benefits relate to both direct and indirect employment as well as funding for community projects.
