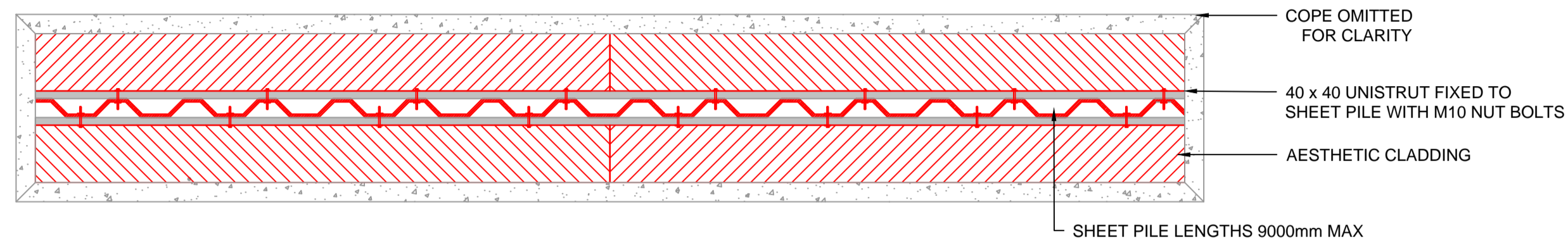

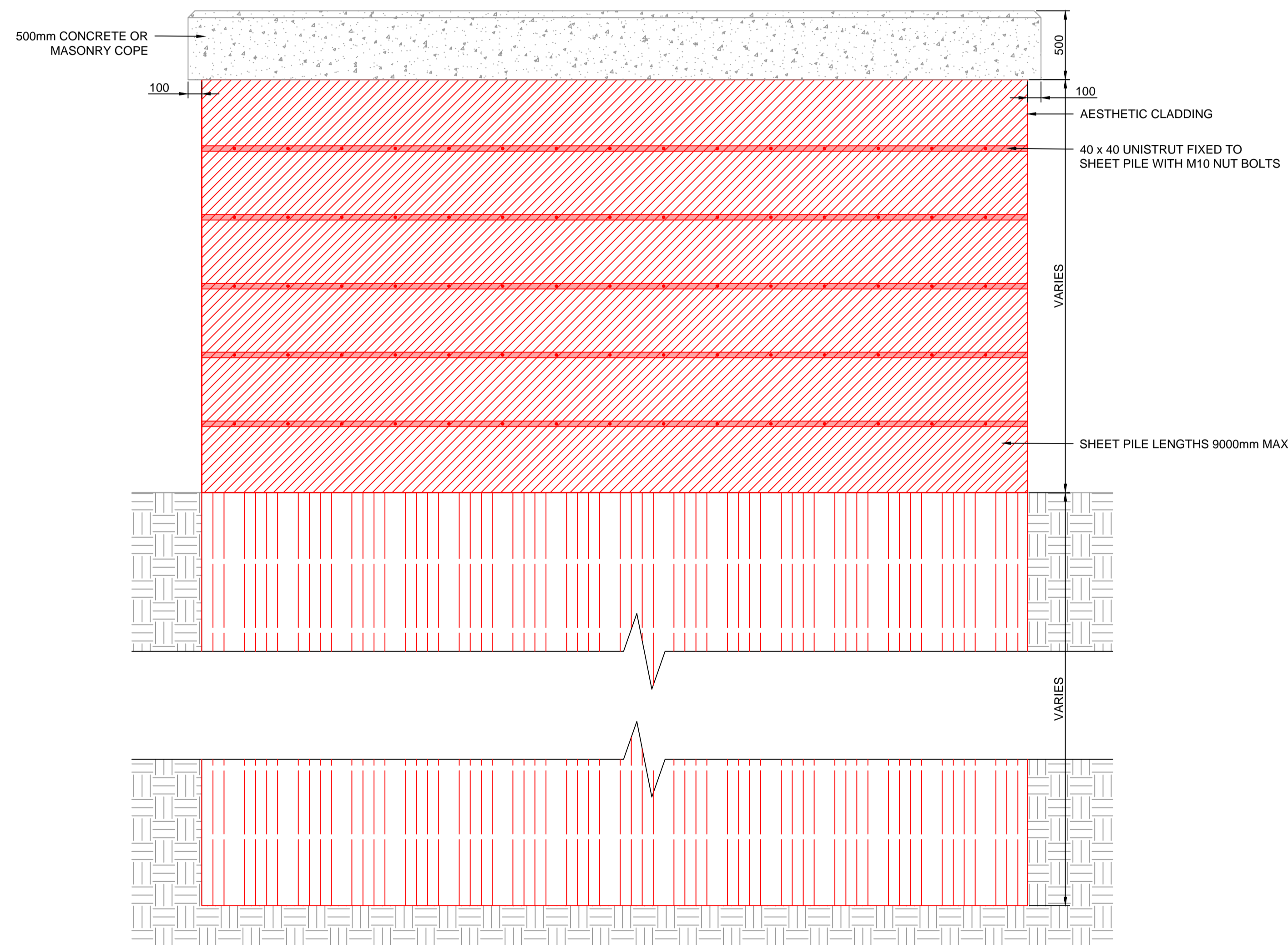

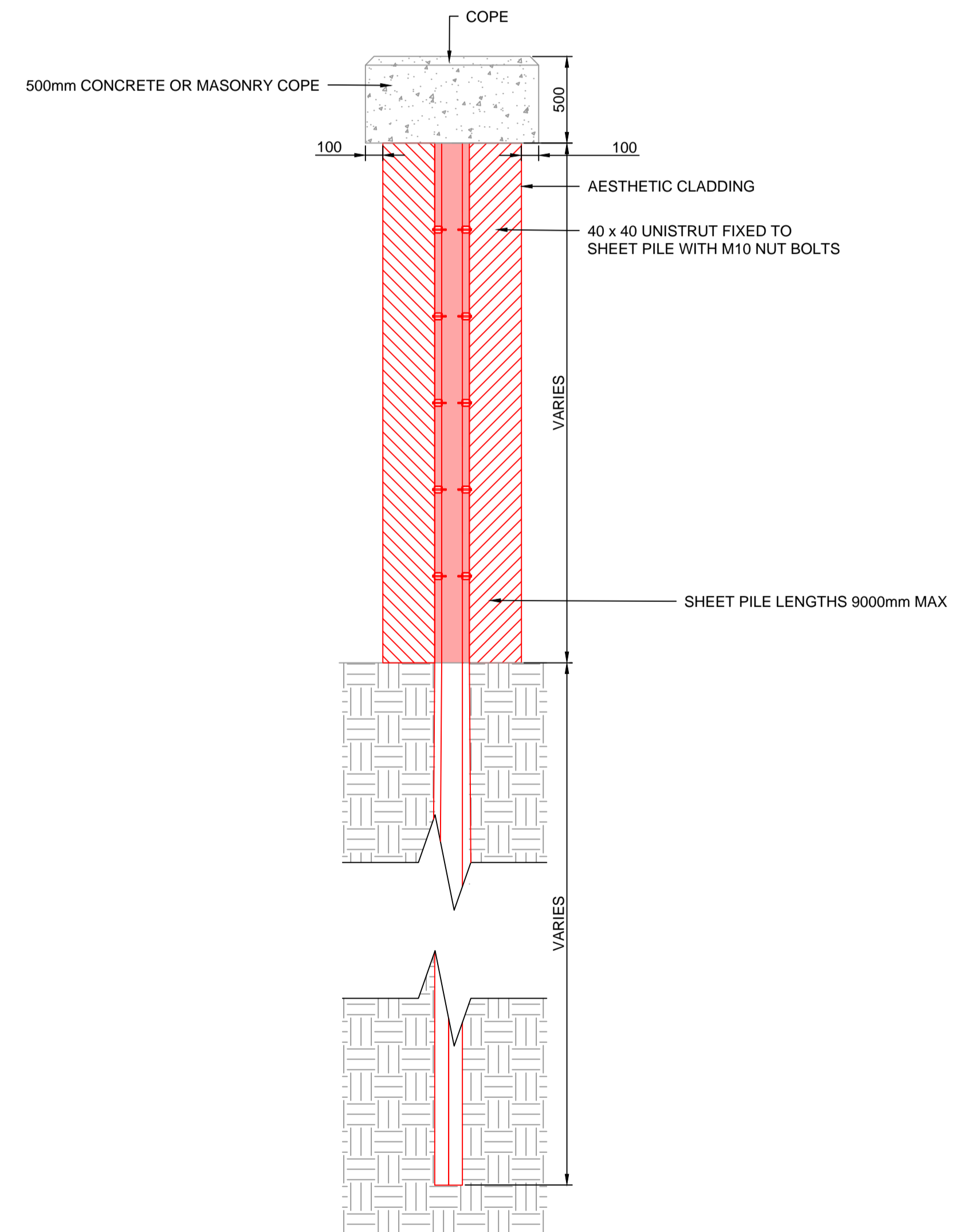
PROPOSED PLAN SHEET PILE FLOOD WALLS WITH CLADDING

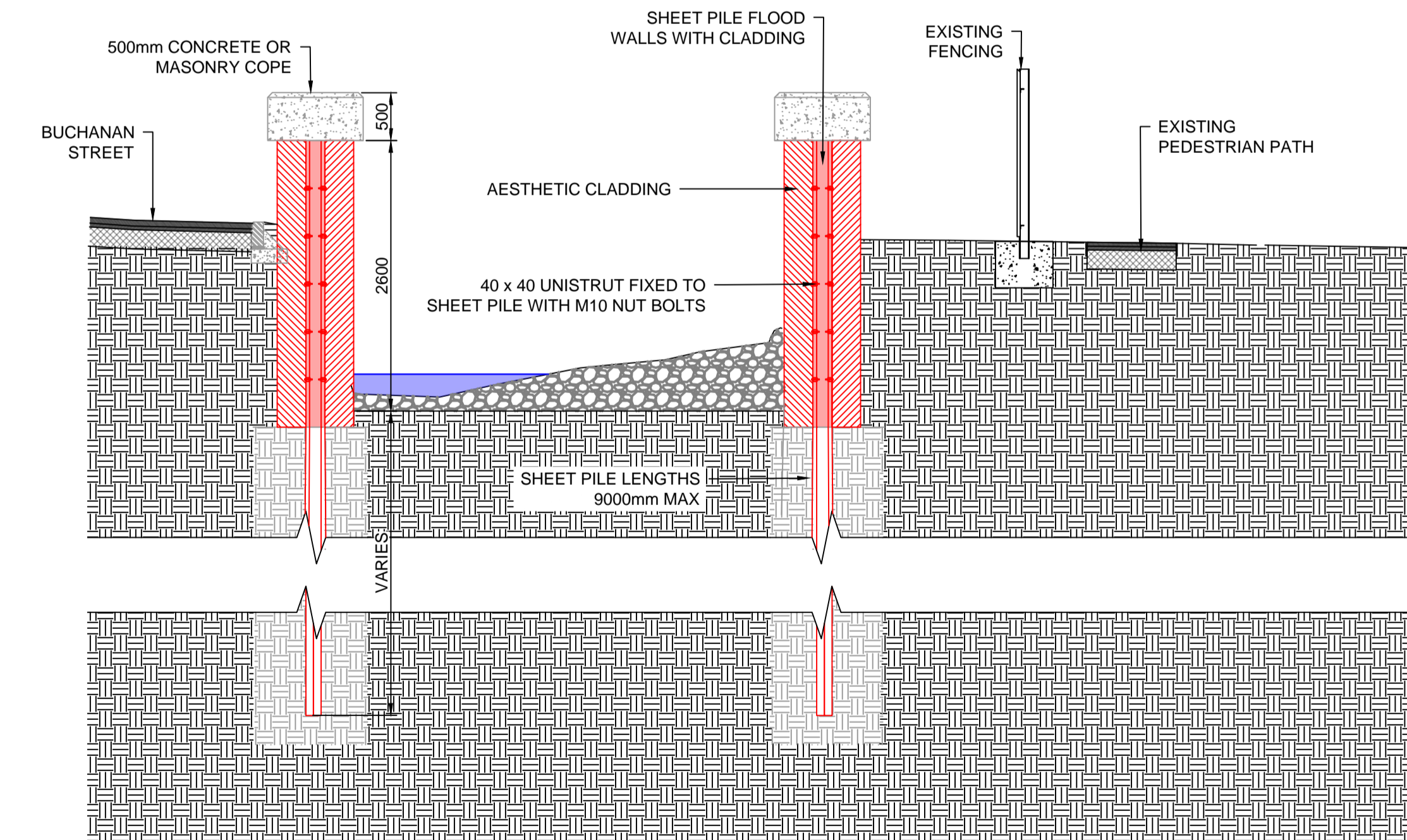
EXISTING SECTION C-C

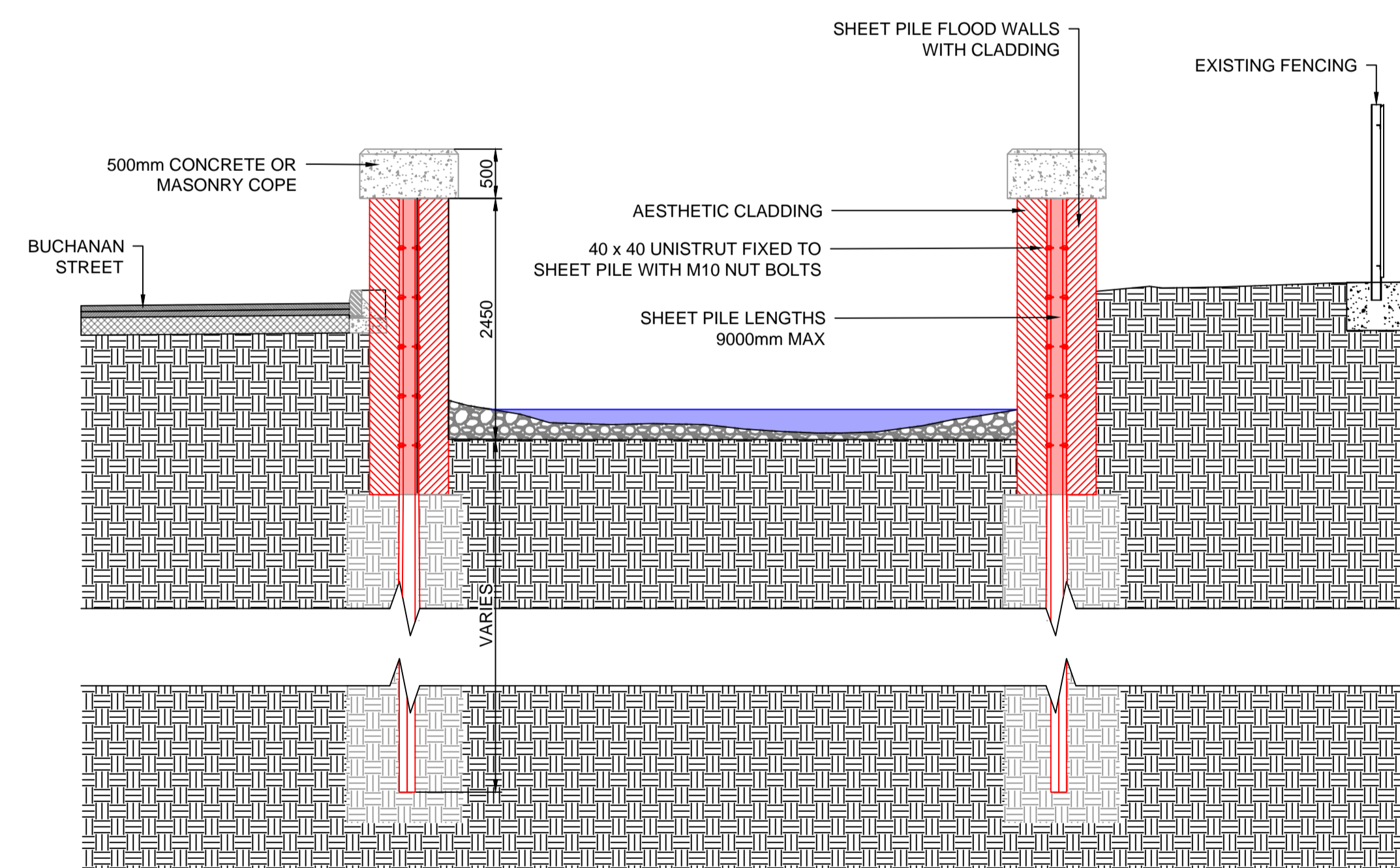
EXISTING SECTION A-A
