Include a list of the latitude and longitude co-ordinates (WGS84) of the boundary points of the moorings area and for each of the component parts of the marine farm, including sub-surface equipment. WGS84 is the World Geodetic System 1984 and the reference co-ordinate system used for marine licence applications. Co-ordinates taken from GPS equipment should be set to WGS84. Coordinates taken from recent admiralty charts will be on a WGS84 compatible datum. Ordnance survey maps do not use WGS84.

**Example:** For positions read from charts the format should be as in the example: 55°55.555'N 002°22.222'W (WGS84). The decimal point specifies that decimals of minutes are used and the datum is stated explicitly. If seconds are used then the format should be as in the example: 55°55'44"N 2°22'11"W (WGS84).

**It is important that the correct positions, in the correct format, are included with this application, as any errors will result in the application being refused or delayed.**

- (g) Indicate if the marine farm is located within the jurisdiction of a statutory harbour authority and provide details of the statutory harbour authority where relevant.
- (h) Provide assessment of the potential impacts the works may have on navigation, including interference with other uses of the sea.

Where there are potential impacts from the works, please provide details of proposed mitigation in response to potential impacts.

## 6. Planning Permission

This application is for an existing farm currently operating and consideration of the 7 objectives and 14 policies relating to Aquaculture within Scotland's National Marine Plan has been given. The farm brings socioeconomic benefits through skilled employment, training opportunities and benefits local population and supply chain in rural area.

The site selection considered the National Marine Plan Policies Aquaculture Policy 1 and 2 'appropriate for development' and 'carrying capacity'; Policy 3 Location Guidelines categorisation; Policy 5 'SNH siting and design of aquaculture', Policy 6 disease management areas, located within area 16d, Policy 7 stringent operational protocols are in place to minimise risk to wild fish stocks, including KFF participation in the Farm Partnership Agreement and signatories of the Environmental Monitoring Plan for the Loch Shuna, Loch Melfort and Loch Craignish with other operators and wild fisheries. Policy 8 consideration of location in relation to seal haul-outs, strict predator management protocols with tiered triggered actions to minimise risk of interaction. Site specific emergency protocols for escapes and equipment attestations confirming suitability for site specific location were submitted with the application with reference to Policy 9 and 11. Biological control of sea lice has been included as an option within the site sea lice control strategy although this can only be used if salmon are stocked.
