Thank you for the opportunity to comment on the Development Specification and Layout Plan for the Moray East OWF. We have the following observations to make:

The developer has previously confirmed that the buffer between Moray East and Beatrice will be five rotor diameters on each side of the boundary with the closet distance between the Beatrice and Moray East turbines being approx. 2.2km. I can't see it mentioned in these plans that the corridor between the Moray East boundary turbines and the Beatrice boundary turbines will be in a straight line.

We would like to remind the developer of the need to liaise with the Moray West developers to ensure consistency across both Moray East and Moray West sites, with regards to the layout, numbering, and lighting and marking.

We note the 50m micrositing and should there be any necessary deviations from this we welcome further discussions to ensure minimal impact on the layout.

The SFF would expect to see clearly that all due consideration is given to fishing as per scotlands National Marine Plan.

To this end the comments on the DLSP are appended;

Ref 3.2.3 any protruding pile, must be accounted for in the decommissioning plan.

Figs 3.4 & 5 it still remains the case that without cable burial this development is a threat to fishing, which must in some way be mitigated/ compensated.

Section 4 OSP- very careful consideration must be given to the burial of cables leading to this, otherwise it's a de facto closed area, which must be mitigated/ compensated.

Section 6 Scour protection – this must be deposited carefully, preferably to lie within the safety zones, or else they close the area and must be mitigated/ compensated.

The same applies to the export cables, which if not buried, must be mitigated/ compensated,
