Include a list of the latitude and longitude co-ordinates (WGS84) of the boundary points of the moorings area and for each of the component parts of the marine farm, including sub-surface equipment. WGS84 is the World Geodetic System 1984 and the reference co-ordinate system used for marine licence applications. Co-ordinates taken from GPS equipment should be set to WGS84. Coordinates taken from recent admiralty charts will be on a WGS84 compatible datum. Ordnance survey maps do not use WGS84.



Example: For positions read from charts the format should be as in the example: 55[°]55.555'N 002[°]22.222'W (WGS84). The decimal point specifies that decimals of minutes are used and the datum is stated explicitly. If seconds are used then the format should be as in the example: 55°55'44''N 2°22'11''W (WGS84).

It is important that the correct positions, in the correct format, are included with this application, as any errors will result in the application being refused or delayed.

- (h) Provide assessment of the potential impacts the works may have on navigation, including interference with other uses of the sea.

6. Planning Permission

The application is to renew and amend the existing expired licence for Nevis B. A planning application has been submitted to Highland Council (10/08/2023) to replace the existing 12 x 80m cages in a 65m grid with 5 x 120m cages in the same grid, replace and relocate the feed barge, and extend the moorings area to the east. As the proposed moorings area expansion is fairly slight (70m), we don't anticipate any impacts on navigation as vessels will still be able to freely pass by to the east of the site. The cage group will continue to be marked and lit in line with NLB requirements.

As per Scotland's National Marine Plan Aquaculture section 11 all equipment on site is fit for purpose and meets statutory technical standards at time of purchase. Moorings are visually inspected annually by qualified diver and/or ROV survey to check for damage and wear and tear.

SSF are committed to reducing our GHG emissions across our business and are signed up the Energy Savings Opportunity Scheme as a means of monitoring and reducing GHG emissions. All machinery on site is regularly maintained to ensure optimum operation. SSF are also compliant with ISO 14001.
