- (e) Provide the cost of the works seawards of the tidal limit of MHWS. This estimate should only cover work taking place below the tidal level of MHWS and must take into consideration the cost of materials, labour fees etc.
- (f) Describe the location of the proposed works. Include a list of the latitude and longitude co-ordinates (WGS84) of the boundary points of the moorings area and for each of the component parts of the marine farm, including sub-surface equipment. WGS84 is the World Geodetic System 1984 and the reference co-ordinate system used for marine licence applications. Co-ordinates taken from GPS equipment should be set to WGS84. Coordinates taken from recent admiralty charts will be on a WGS84 compatible datum. Ordnance survey maps do not use WGS84.







**Example:** For positions read from charts the format should be as in the example: 55°55.555'N 002°22.222'W (WGS84). The decimal point specifies that decimals of minutes are used and the datum is stated explicitly. If seconds are used then the format should be as in the example: 55°55'44"N 2°22'11"W (WGS84).

- (h) Provide assessment of the potential impacts the works may have on navigation, including interference with other uses of the sea.

Where there are potential impacts from the works, please provide details of proposed mitigation in response to potential impacts.

#### 6. Planning Permission

(h) Potential impacts the works may have on navigation and proposed mitigation in response to potential impacts (continue on separate sheet if necessary): Application for renewal of existing licence and no changes or new deposits anticipated. The development will be held in place by a subsurface mooring grid that will not encroach on any recognised anchorages, navigational channels or navigational light sectors. Appropriate lights, buoys and beacons, those which comply with the international Light House Authorities guidelines, will be used to mark the installation. The Northern Lighthouse Board and Shetland Islands Council have been consulted in all stages of the development. The site and all equipment will be checked on a weekly basis and after storm events. Records will be kept of its physical state for audit purposes. Although unlikely, in the event of cages moving off the mooring positions, this may cause potential navigational interference however, Cooke Aquaculture Scotland will ensure all equipment is considered and proven to be capable of withstanding the environmental conditions at the site. Cooke Aquaculture Scotland have also adopted the Marine Scotland Technical Standards for Scottish Finfish Aquaculture and will be audited to these standards. **Planning Permission** YES ■ NO □ Do you have planning permission for the marine farm? YES ■ NO □ If YES, provide details of considerations made including reference to the policies that have been considered: Scotland's National Marine Plan outlines a total of 7 objectives and 14 policies which relate specifically to aquaculture. All have been given consideration as part of this process, and details are as follows: Policies 1-8: The location of the site was carefully chosen to minimise impacts relating to carrying capacity/locational quidelines, visual amenity, disease management areas, wild fish and seal haulout sites. All required modelling and assessment was also conducted and the site is considered to be within all required limits. Policy 9: Emergency response plans are in place for the site. Policy 10: Statutory and non-statutory pre-application consultation carried out prior to submission of application. Policy 11: Equipment attestations from manufacturers available for all proposed equipment and detailed mooring modelling also conducted. Site will also be compliant with Marine Scotland Technical Standards for aquaculture. Policy 12: Cooke Aquaculture owns and operates a dedicated hydrolicer vessel and has access to freshwater treatments for lice removal. Policy 13: Cooke Aquaculture Scotland is actively researching the potential for Integrated Multi-trophic aquaculture. Policy 14: Community benefits relate to direct and indirect employment as well as funding for community projects.
