Include a list of the latitude and longitude co-ordinates (WGS84) of the boundary points of the moorings area and for each of the component parts of the marine farm, including sub-surface equipment. WGS84 is the World Geodetic System 1984 and the reference co-ordinate system used for marine licence applications. Co-ordinates taken from GPS equipment should be set to WGS84. Coordinates taken from recent admiralty charts will be on a WGS84 compatible datum. Ordnance survey maps do not use WGS84.



Example: For positions read from charts the format should be as in the example: 55[°]55.555'N 002[°]22.222'W (WGS84). The decimal point specifies that decimals of minutes are used and the datum is stated explicitly. If seconds are used then the format should be as in the example: 55°55'44''N 2°22'11''W (WGS84).

It is important that the correct positions, in the correct format, are included with this application, as any errors will result in the application being refused or delayed.

Existing site, expansion from 9x80m circumference pens in a 65m grid to 12x100m circumference pens in a 80m grid. Most of the expansion will be to the SW, with relatively minor increases to the NE and E (see attached overlay drawing). As at present, navigational markers will be deployed in line with NLB/Marine Scotland requirements. The proposed expansion is not considered likely to have any effect on safe navigation.

As per Scotland's National Marine Plan Aquaculture section 11 all equipment on site is fit for purpose and meets statutory technical standards at time of purchase. Moorings are visually inspected annually by qualified diver and/or ROV survey to check for damage and wear and tear.

SSF are committed to reducing our GHG emissions across our business and are signed up the Energy Savings Opportunity Scheme as a means of monitoring and reducing GHG emissions. All machinery on site is regularly maintained to ensure optimum operation. SSF are also compliant with ISO 14001.

Where possible any equipment used on site is recycled at the end of its life.

Navigational marker buoys are deployed at this site as per NLB recommendations and are regularly maintained to ensure good working order.

The proposal has been through public and statutory consultation twice, first through SEPA CAR licensing and subsequently through local authority planning. The CAR licence variation was granted on 31/07/2020, with a deferred start date of 01/09/2021. Consultation in respect of planning has now closed, and all responses can be viewed on Argyll & Bute Council's planning portal (ref 20/02359/MFF).
