WGS84 is the World Geodetic System 1984 and the reference co-ordinate system used for marine licence applications. Co-ordinates taken from GPS equipment should be set to WGS84. Coordinates taken from recent admiralty charts will be on a WGS84 compatible datum. Ordnance survey maps do not use WGS84.

**Example:** For positions read from charts the format should be as in the example: 55°55.555'N 002°22.222'W (WGS84). The decimal point specifies that decimals of minutes are used and the datum is stated explicitly. If seconds are used then the format should be as in the example: 55°55'44"N 2°22'11"W (WGS84).

Drawings and plans will be consulted upon. If they are subject to copyright, **it is the responsibility of the applicant to obtain necessary approvals to reproduce the documents and to submit suitably annotated copies with the application.**

- (h) Indicate if the mooring is located within the jurisdiction of a statutory harbour authority and provide details of the statutory harbour authority where relevant.
- (i) Provide assessment of the potential impacts the works may have, including interference with other uses of the sea. Lochs Creran, Alsh, Duich and Long are designated as Special Areas of Conservation (SAC) under the Habitats Directive (Council Directive 92/43/EEC). Loch Creran has been selected for its bedrock and biogenic reefs of the tube worm *Serpula vermicularis* and the horse mussel, *Modiolus modiolus* and Lochs Alsh, Duich and Long for their sublittoral rock (marine) reefs. All are very sensitive to physical damage from anchors and the placement of moorings and in order to assist their protection reference should be made to the special moorings pack which can be downloaded from the following link: <http://www.scotland.gov.uk/Topics/marine/Licensing/marine/Applications>

The application is for the continued licensing of an existing mooring, for use by workboats serving the existing marine finfish farm operations in the area. Vessels using the mooring range from small personnel boats to vessels of a maximum 24m length.

The mooring is not within any designated conservation areas, nor any shellfish harvesting areas (Shellfish Water protected Area or Classified Shellfish Harvesting Area).

No adverse impacts are anticipated.

The proposal is in alignment with policy GEN 1, supporting the ongoing operation of the existing marine farms in the area which are operating with good practice & performance compatible with the NMP's Aquaculture policies (in particular AQ 1, 3, 12 & 14). Supporting the ongoing farm operations also aligns with policies GEN 2 & 3, ensuring continued socio-economic benefit in the local area in terms of employment, training opportunities, local community engagement and supply-chain use. Policy GEN 4 is also met, with the proposal being compatible with the ongoing activities of other marine users. As above, there are no historic environment (GEN 6) or natural heritage interests affected by the proposal (GEN 9), and being an area of well-established activity both on shore and at sea, no negative impact on landscape, seascape or local amenity are identified (GEN 7 & AQ 5). Finally, in alignment with policy AQ 11, the proposed equipment is fit for purpose and will be routinely maintained by the operator.
